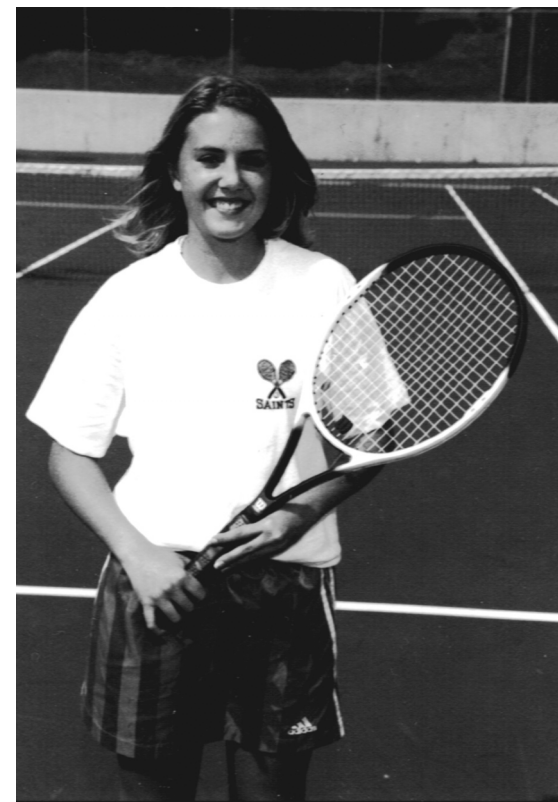


Tournament Information

Headquarters:	Tom O'Leary Tennis Complex
Entry Fees/Format:	Juniors: Singles \$15.00; Doubles (per team) \$20.00 Adults: Singles \$25.00; Doubles (per team) \$32.00 All matches will be 2 out of 3 sets—Super tiebreaker for 3 rd set
Awards:	Trophies: Draw events 1 st , 2 nd , and Consolation. Round robins: 1 st and 2 nd .
Participation Limit:	1 Singles and any 1 Doubles or 1 Doubles and 1 Mixed Doubles or 1 Doubles and Social Doubles 1 60 & Over Doubles and any 1 other Doubles
Note to Juniors:	Singles events will be played in the morning and Doubles events in the afternoon. Enter accordingly.
Age Requirement:	Since this is not a USTA event, juniors may enter the age division in which he or she falls as of June 6. Players in an adult division must be a high school graduate, except Social Doubles and Mixed Doubles
Seeding Information:	Please provide information, such as USTA ranking, high school position, or tournament results, to help us with seeding.
Entry Deadline:	Junior forms must be received by 6 pm, Sunday, June 2. Adult forms must be received by 6 pm, Monday, June 3.
Draw Sheets:	Draw sheets will be posted on the web at bmta.usta.com according to the following schedule: Juniors by 6:00 p.m. Wednesday, June 5. Adults by 6:00 p.m. Thursday, June 6.
Check-in/ Starting Times:	Junior check-in time is 8:30 a.m., Thursday, June 6. Play begins at 9:00 a.m. Thursday. Adult check-in time is 5:30 p.m., Friday, June 7. Some first round matches may begin on Friday at 6:00 p.m. If you cannot play at that time, note it on the entry form.
Tournament Souvenir:	Each participant will receive a tournament T-shirt.
Tournament Social:	A social will be held at 6:00 p.m., Saturday, June 8 at the Tom O'Leary Courts. Food/Prizes will be provided. Players need not be present to win the larger prizes.

Jackie was born February 21, 1982, in Bismarck to Celia (Cec) and Jerry Dockter. She attended Northridge Elementary, Cathedral, and St Mary's Central High School. Jackie was known for her accomplishments both on and off the tennis court. She was the West Region Girls' Singles Champion in 1999 and placed third in the North Dakota State Girls' Tennis Tournament. She was a member of the National Honor Society and was a cheerleader for the boys' basketball team and captain of the football cheerleading squad. In her senior year she was elected St. Mary's Homecoming Queen.

Her love for children was apparent when she taught summer lessons for the Bismarck Parks and Recreation District.

Jackie died November 3, 1999, at St. Mary's Hospital in Rochester, Minnesota, six weeks after being diagnosed with a brain tumor.

What Jackie was most known for was how she made people feel. She had a special gift of making people laugh with her quick wit. Her enthusiasm for life crossed school boundaries. She made friends with so many, not only in the Bismarck/Mandan area, but also across the entire state. Jackie is missed by many.
