OSWTA is incorporated as a non-profit 501(c)7 organized to promote recreational tennis. The OSWTA Board supports tennis as a life-long activity. Grants to support programs that serve underprivileged children have been awarded in recent years to help fund programs in Longview, Vancouver, Keizer/Salem and Corvallis.

As part of the dissolution process three grants have been awarded this year. The first grant was awarded to the Northwest Wheelchair Tennis Association to help fund a 9 week program for junior wheelchair tennis players. The second was awarded to VTC to help fund the Arlene Clark Scholarship Program for Kids. The third was awarded to Timberhill RC. The last two grants provide children of low income families the ability to participate in tennis lessons.
