5. 2018 Highlights of National Regulations

- 2.01A(1): Plus (+) leagues are allowed to roster (Ad 18& 5.0+:2, Ad 40& 4.5+:3) players at the higher level but only 1 (5.0+) or 2 (4.5+) can play in a team match.
- *new for 2017* 2.06: National Championship teams are required to Move Up or Split Up only in the age group from which their team advanced the previous year.
- 2.03A(4): 3 match minimum includes "One default" to advance to Nationals
- All players are eligible to appeal their rating except Nationals Benchmark players for the year following their National Championship

6. Eastern MA Local League Regulations

- 2.1.4: Adult 40 & Over 4.5+ format *new* 2 singles and 3 doubles
- 2.4: Pay as You Play match fee \$18.00pp. Review EMA Timeline Match Fees Procedure
- 2.5: In level requirements
- 3.1 & 9.3: Once you receive notice that your schedule is published, review it with your club to ensure there are no conflicts. Confirm receipt with Viola within 72 hrs. & immediately if there any changes.
- 3.10.6: *new* Interruption of a match before it is completed when caused by the host club.
- 3.14.6: Make Up matches for holidays and rescheduled matches (weather, court conflicts)
- 3.14.7 and 3.14.9: Rescheduled Matches *new* changes to outdoor make up matches and send the new match date within one week (instead of 48 hrs.) after the originally scheduled date.
- 5.1: Team defaults/Multiple individual defaults
- Foot Faults & line calls reminder that league matches are timed un-officiated matches error on the side of benefit of the doubt – FAC pg. 10 #18, The Code pg. 39 #24
- 7. Sportsmanship: Review causes for Grievances & procedure/reasons, when and why to submit
