The United States Tennis Association South Carolina announces its 12th annual Campus Championship. We'd be honored to have your college or university participate in this tournament designed for players at the intramural or club sport level.

Date: November 19 - Captain's Meeting, Team Play, Lunch & Dinner

November 20 - Team Play & Lunch

Entry Fee: \$20 per player includes an event t-shirt, awards/prizes, Saturday lunch & dinner and Sunday lunch. In addition to the entry fee, each team is required to send a separate deposit check of \$100 which will **not** be cashed. The deposit will be held and returned at the conclusion of the tournament. However, if a team leaves before all their scheduled matches are played or fails to provide an eligible line-up for a match with a mathematical chance of winning, that team will forfeit their deposit.

Registration Deadline: Friday, November 11, 2016 Surface: Hard (8) & Clay (2) Courts

Captain's Meeting: Mandatory captains meeting before play on Saturday morning, time TBD.

Tournament Format: Teams will be randomly flighted according to the number of team entries. Each flight will play a round robin. Flight winners will then compete for the championship. Each team is guaranteed a minimum of three team matches. The format is subject to change prior to the tournament or during for inclement weather.

Team Matches & Tournament Scoring: A team match consists of five no-ad sets and includes men's singles and doubles, women's singles and doubles, and mixed doubles. Mixed doubles is played last. Each no-ad set is won by the first team to reach six games. A nine-point tiebreaker will be played at 5-5 in any set. A team match is won by the team with the most cumulative games won from the 5 sets played. Flight winners are determined by their win/loss record in round robin play. Scoring format is subject to change as needed for inclement weather.

Team Eligibility: Each team must have a minimum of 2 men and 2 women with a limit of 8 players on a team roster. We recommend 3 men and 3 women. Only 1 former collegiate varsity player per team is allowed. Multiple teams from a college or university are encouraged, but a player may only participate on one team roster.

Individual Eligibility: Please visit http://www.tennisoncampus.com/Resources/EligibilityRules_Guidelines.htm for complete rules. Active 2016-2017 varsity tennis team members are not eligible for play in this tournament.

Rules: USTA rules and WTT scoring will be followed throughout the tournament where applicable. Any variations will be discussed at the mandatory Captain's Meeting.

The top placing team from South Carolina is eligible for a **\$500 travel stipend** to participate in the USTA Southern Section Tennis on Campus Championship held February 24-26 in Auburn, Alabama.
