Ranking Information: All matches in this event will count towards ranking with the exception of mixed doubles. This event may be used towards the completion of national ranking requirements for this age group. Zonals are considered a Level 2 National Event.

Scoring Format: Regular scoring, two out of three sets, with a twelve-point tiebreak played at six games all. Alternative scoring formats may be used in the mixed doubles and in case of inclement weather. We will be using a round robin format this year.

Coaching: There will be coaching allowed during the odd-game changeovers. Only the designated coaches may communicate with the players. If players split sets during a regular scoring match, there will be a mandatory ten-minute break.

Officiating: Play will be subject to the rules of the USTA. The USTA Point Penalty System will be in effect throughout the tournament. NO UNSPORTSMANLIKE CONDUCT WILL BE TOLERATED. There will be USTA certified umpires at the site in addition to USTA court monitors.

What Else to Bring: It will be HOT! Please bring sunscreen and anything else you might need to help you prevent too much sun. Water jug, white hat, extra shirt and towel are also suggested. There will be no towels available on site.
