## NJT Background

The NIKE Junior Tour (NJT) are junior tournaments for boys and girls, 12's and 14's. The NJT is currently played in 23 countries with over 45,000 players participating in 2005. Eleven USTA sections are participating this summer. The Southern Section will hold 3 NJT events.

The NJT has regional tournaments in each country followed by a national playoff. The USA Masters will be held at Stanford University, California, September 23-25, 2004. Four national winners (a boy and girl for both 12's & 14's) represent their country in the NJT International Masters at Club Med in Agadir, Morrocco, November 2005.

NJT USA is being held this summer in 11 Sections of the USTA. The draws will be 32 singles with a consolation for first round losers. Players will accumulate points based on rounds won. Points earned will determine the NIKE USTA Junior Rankings, which will be published in the print media and on the internet. The top finisher in each age group from the Southern Section will play off with the top four finishers from other USTA Sections to determine who will represent the United States at the NIKE Junior Tour International Masters in November. NIKE will provide a coach and pay all travel and tournament expenses for the U.S. team attending the event.

## Tournament Rules:

NOTE: Players may enter NJT events even if the dates coincide with USTA sanctioned event dates. Explanation: NJT events are not currently sanctioned by the USTA, therefore entering an NJT event whose dates coincide with that of an USTA event, does not violate the concurrent USTA tournament rules.

- 1. IMPORTANT NOTE: Only players, who meet the ITF (International Tennis Federation) eligibility cutoff of December 31, will be eligible to play in the NJT events. Example: If you are currently 12 but will turn 13 on or before December 31, 2005, you cannot play in the 12's and therefore must enter the 14's.
- 2. Players must be current USTA members and show their USTA card at check-in.
- **4.** Rules of the USTA and section entered will govern play except when superceded by Nike Junior Tour rules, i.e. using the ITF eligibility rule rather than the USTA eligibility rule.
- **5.** Point penalties for tardiness and conduct control will be used.
