## 2017 USTA Pacific Northwest Travel Assistance Grant Application

The purpose of the USTA Pacific Northwest (USTA/PNW) Travel Assistant Grant program is to provide <u>need-based financial support</u> to players who would not otherwise have the financial means to travel and participate in national tournaments. Players participating in national championship tournaments may complete this application to apply for a <u>need-based</u> Travel Assistance Grant.

**Requirements** (If you do not meet both requirements your application will NOT be considered)

- The main criteria used by the Travel Grant Review Committee will be the overall financial need of each applicant. <u>Financial need will be defined as an applicant that has a family gross income</u> of \$25,000 or less per person within the applicant household.
- Applicant must commit to volunteer during one of the section's junior tennis events listed below.
   In considering a travel grant application, the review committee will examine the player's as well as the parents' willingness and ability to volunteer.

Please note that applying for a travel grant does not guarantee you will receive financial assistance. USTA/PNW Travel Assistance Grants are to be used for travel and tournament expenses for the **player only** and may not be used for family members, coaches, or for other purposes. Players are required to provide supporting documentation of expenses to the USTA/PNW office within two (2) weeks after returning from the national tournament for which a Travel Assistance Grant is awarded.
