## **Event Format**

Matches begin at 8:00 am November 18 – 20<sup>th</sup>. Be prepared to start play at 8:00 AM. Scheduling accommodations will not be made for individuals participating in more than one NTRP level.

# Round Robin Format (1 team from each Section, 5 teams total)

Best of two tiebreak sets with a match tiebreak at one set all; no coaching allowed. The match tiebreak shall be scored as 1 set and 1 game for tiebreak procedures. Two minute set rest between the 1<sup>st</sup> and 2<sup>nd</sup> set and between the 2<sup>nd</sup> set and the match tiebreak if required.

The format may be changed due to inclement weather. In the event of a tie in the round robin (two or more teams with the same team record) the champion and 2<sup>nd</sup> place team will be decided by:

- 1. Most individual matches won
- 2. Fewest sets lost
- 3. Fewest games lost
- 4. Head to Head winner
- 5. Coin Toss

If inclement weather or other circumstances prevent the completion of tournament play, and the Tournament Committee has not cancelled the event, these tiebreak procedures will be used to declare a champion and a finalist in each level.

## **Awards**
