### **OFFICIAL RULES AND REGULATIONS:**

#### **I. Name of Sponsor**

Climb for Cancer Foundation (hereinafter referred to as "CFCF") and USTA Florida Section Foundation (hereinafter referred to as "FSF") are 501(c)(3) not-for-profit organizations operating in the State of Florida. 2009 Courtside Tickets were received from the USTA President, with the intent that the tickets would be used as a fundraising vehicle for the CFCF and FSF. All proceeds of the Raffle will be split equally between CFCF and FSF.

*The following prizes were donated:* two (2) tickets to the USTA President's Box including complimentary US Open Bus transportation from the Grand Hyatt to USTA Billie Jean King National Tennis Center, lunch in the President's Dining Room, hospitality in the President's Suite, and access to courtside seating in Louis Armstrong Stadium as well as Grandstand and all other courts. Two (2) Courtside Seats in Arthur Ashe Stadium, and the two (2) nights stay at the Diplomat Hotel in Hollywood, Florida with a Twosome of Golf

The minimum donation for each raffle ticket is \$50.00.

Persons obtaining raffle tickets in person will receive their raffle tickets immediately. Persons obtaining tickets by phone and purchased with a credit card will receive tickets via US mail. Tickets purchased obtained by telephone and purchased by check will be mailed upon receipt of the check. It is the responsibility of each party requesting a raffle ticket to provide a valid, deliverable mailing address to USTA Florida.

The right to limit the number of tickets issued to each drawing entrant is expressly reserved.

A valid raffle ticket must be presented in order to claim the prize. CFCF and FSF may require verification of eligibility and identity before releasing prize.

CFCF and FSF and their agents, Board, vendors, volunteers and members assume no liability for lost, late, misdirected, mutilated, incomplete, illegible, or undelivered ticket. Any lost, late, misdirected, mutilated, incomplete, illegible, or undelivered tickets shall be deemed invalid and shall be immediately disqualified.
