Wild Card Qualifying Tournament

Tournament is open to all 3.0, 3.5, 4.0 & 4.5 teams registered in the 2015 USTA 18 & Over Adult League. Limited to the first 6 teams to register in each individual NTRP division.

Winning teams from each NTRP division will advance to
2015 USTA 18 & Over District Playoff

Dates of Play: May 26-30, 2015

Deadline: May 16

- Each team is guaranteed a minimum of 2 matches
- Weeknight matches will begin at 5:30 PM and Saturday matches begin at 8:00 AM
 - Limited to the first 6 teams to register in each individual NTRP division
- All USTA Adult League Regulations (except as noted above) and "The Code" are in effect.

Team matches will use the same format as in the USTA 18 & Over adult league

- 2 singles, 3 doubles using regular scoring with a match tiebreak in lieu of a third set
 - Each division will have 2 flights with a playoff between flights A & B

Team rosters:

- Only teams entered in the USTA 18 & Over Adult League are eligible to enter.
- Teams entered must consist of only those players who are registered on TennisLink and appear on the roster as of May 25, 2015.

The winning teams in the men's and women's divisions will qualify for advancement in the Utah District Championships, July 30-August 1, 2015. Should the winning Men's & Women's team in the tournament also become eligible to advance to the District Championships by virtue of their league standings, the league standing would take precedence and the 2nd place team in the qualifying tournament would be selected to advance to the District Championships. Should the first and second place teams in the qualifying tournament become eligible by virtue of their league standing, the 3rd, 4th, or 5th place team in the qualifying tournament would become eligible to advance to the District Championships.

This is a non-sanctioned event and match results will not be used for computing NTRP ratings. Individual matches played in the qualifier do NOT count toward the required number of matches needed in order for a player to advance to a District or Sectional Championship.

Eligibility: Winning teams from the qualifying tournament must have completed all of their USTA Adult Summer League Matches (without any team defaults), as well as all round robin matches in the tournament in order to become eligible to advance to the District Championships.

No refunds will be issued for any reason after the tournament deadline.
