Wild Card Qualifier Tournament

Winners advance to
2018 USTA Adult 40&Over League Utah District Tournament

This tournament is open to 3.0, 3.5, 4.0 & 4.5 teams registered in the
2018 USTA 40 & Over Adult League

Dates of Play: July 6-7, 2018
Team Entries Due: June 27

Friday matches will be from 1:00PM to approx. 7:00 PM
Saturday matches will be from 8:00 AM to approx. 6:00 PM

Team matches will use the same format as in the USTA Adult 40&Over League:
2 singles, 3 doubles using regular scoring with a match tiebreak in lieu of a third set

Adult 40 & Over Team rosters

Only teams entered in the USTA 40&Over League are eligible to enter.
Teams entered must consist of only those players who are registered on TennisLink and appear on the team roster. Players who are rostered on two teams may compete in this tournament for both teams but no schedule accommodations will be granted.

The winning teams in the Men's and Women's divisions will qualify for advancement in the Utah District Championships, August 23-25, 2018. Should the winning Men's & Women's team in the tournament also become eligible to advance to the District Championships by virtue of their league standing, the league standing would take precedence and the 2nd place team in the qualifying tournament would be selected to advance to the District Championships. Should the first and second place teams in the qualifying tournament become eligible by virtue of their league standing, the 3rd, 4th or 5th place team in the qualifying tournament would become eligible to advance to the District Championships.

This is a non-sanctioned event. Match results will not be used in computing NTRP ratings. Individual matches played in the qualifier do NOT count toward the required number of matches needed in order for a player to advance to a District or Sectional Championship.

Eligibility: Winning teams in the qualifying tournament must have completed all of their USTA Adult 18&Over League Matches (without any team defaults), as well as all round robin matches in the tournament in order to become eligible to advance to the District Championships.

Fees: \$12 per player per match

Total payment will be collected from captain once the total number of matches is determined.
Tournament will be cancelled, with full refund, in case of inclement weather.

All USTA Adult 40&Over Regulations (except as noted above) and "The Code" are in effect.
