Location: University at Buffalo, North Campus (Amherst), Ellicott Tennis Courts.

Directions to Campus (from the east): Take the I-90 West until you reach the I-290 (just past tolls, follow State University signs). Take the I-290 West (toward Niagara Falls) to Exit 5B (Millersport Highway, Route 263). Get off exit and merge into traffic. Go through first light (Marriott is on your left), and merge into right lane. Enter campus at the Flint Road exit. Campus map on p.3 of this document.

Surface: Hard

Registration: Register by sending an email to Lynn Buffamonti: bncta1@gmail.com, **before Tuesday, August 2nd**. On game day, bring a check payable to: **BNCTA**. Scorecards will be available at the tournament desk. Reminder: USTA regulations state that a team cannot advance unless they have a full team (eight players).

Game Day: All players are required to be on site, ready for play 30 minutes prior to scheduled match time. Matches will begin early if courts are available. There will be a 30-minute rest period between individual matches at the same level. This does not apply for those playing two levels.

Format: Best of three (3) sets, 10-point tie break in lieu of third set.

ALL TIE BREAKS USE COMAN FORMAT: Coman format to be used at 6-6 in first two sets and for the 10-point, 3rd set, tiebreak. This format allows servers to continue to serve on the side they have been doing throughout the set.

Awards: First place teams at each level will receive eight awards and advance to USTA Sectionals. Check <http://www.eastern.usta.com> for dates and schedules.
