Section 4. Vehicle Restrictions. No trucks, trail bikes, all-terrain vehicles, recreational vehicles, busses, campers, trailers, boats, or boat trailers ("Restricted Vehicles") shall be parked, stored or in any manner kept or placed over night on any lot within the properties except within an enclosed garage or carport. No motorized trail bikes, all-terrain vehicles, go carts, motorized go peds, or similar vehicles may be operated within the Properties. Golf carts may be operated within the Properties and shall comply with Florida State law. This restriction shall not be deemed to prohibit: (a) commercial and construction vehicles, in the ordinary course of business, from making deliveries or otherwise providing service to the properties:) b) the parking of a Restricted Vehicle by an Owner's guests or invitees except from 1:00a.m. To sunrise on weekdays and from 2:00 a.m. to sunrise on weekends and state or national holidays. Restricted Vehicles may be washed outside of an enclosed garage or carport during hours and for a period of time determined by the Architectural Committee.

(a) No trucks bearing any signage, ladder racks, side tool boxes, advertisements, or containing any equipment or materials of any kind that can be observed from plain view shall be allowed to be kept overnight on any lot or residence except within an enclosed garage. All trucks must be able to fit within the confines of an enclosed garage to meet requirements of this provision.
