The Health Ministry at Prince of Peace Catholic Church invites you to join in on a virtual pilgrimage! A pilgrimage to walk, run, bike, swim, golf or exercise your way, virtually, along the Camino de Santiago trail beginning in France and ending in Spain.

The Camino de Santiago (Walk of St. James) was created and established in the beginning of the 9th century following the discovery of the relics of Saint James the Great. The Way of St. James became a major pilgrimage route of medieval Christianity from the 10th century onwards.

The virtual pilgrimage will last for 33 weeks, representing the 33 stages of the Walk, and will commence on **Sunday, November 2nd**, concluding on **Sunday June 21st**.

Every Sunday morning you will receive, via email, health tips, encouragement and colorful photos capturing each of the 33 stages of the route. **Fun stuff!** Your *virtual miles*, which are the minutes accumulated (from your week's walking, running, biking, swimming, golfing, exercising, even yardwork!), will be reported to Tom Rose (La Paloma), and added to the team's total.
