



On behalf of our entire Board, a very Happy New Year to all of our residents!

Our Association now has a storage unit where we are currently storing all of our Christmas decorations and is available to our sub-Associations to store their entry Christmas decorations as well. (storage unit is not available for individual resident use) At this time, we are seeking bids to repair the electrical issues at the main Cypress Village Boulevard entrance at SR 674.

The Design Review Committee (DRC) is developing language pertaining to Hurricane Shutters. Currently, there are no guidelines for the time to install and take down.

And speaking of the DRC, please follow the guidelines for DRC submittals. The main reason for not approving applications is missing information. We invest time at the DRC meetings trying to figure out what is requested only to send it back for more information. Reminders to all residents:

Dog owners are required to restrain their animals with a fence or leash...

Under the Hillsborough County Animal Ordinance. [ARTICLE II. - ANIMAL CONTROL., Sec. 6-19.d)] "In order for a dog or cat to be allowed on a public street, road, park or other public property, excluding public right-of-way on an owner's private property or unless otherwise specifically permitted, the dog or cat shall be under the direct control of the owner or keeper." [Sec. 6-28.] The use of the word "shall" means that this is a mandatory requirement. "Direct control shall mean immediate, continuous physical control of an animal at all times, such as by means of a fence, leash, cord or chain of such strength to restrain the animal."

Lastly, as noted by a concerned resident of Ventana, please do not block driveways/sidewalks with vehicles. It is a safety issue. Walkers are left to walk in the streets which can be unsafe.

Hear Ye Hear Ye ~ New Florida Laws/Bills Effective January 1st 2024



SB 774: Ethics Requirements for Public Officials

This new law is perhaps the most controversial coming into effect. It requires elected city officials to disclose finances in greater detail, bringing them in line with many other politicians in the state like the Florida Cabinet and Legislature.

HB 1627: Pretrial Release and Detention

HB 1627 has numerous provisions but its biggest changes stiffen pretrial release options depending on an accused prior criminal history and status.

HB 425: Transportation

"Florida's Move Over" Law: Drivers already have to move over or slow down for stopped emergency vehicles, sanitation, utility and construction vehicles stopped on the side of interstates and highways. Now, that will also include moving aside for disabled vehicles with hazard lights, emergency flares or signage. The same goes for vehicles that are stopped with at least one person visible.

HB 121: Florida Kidcare Program Eligibility

While the law's effective date was in June of 2023, Florida's Kidcare Program needs to have its planned expansion ready by the start of 2024. The program funnels federal aid to families who need help with their children's medical costs but don't qualify for Medicaid. Under the expansion, those with household incomes up to 300% of the federal poverty level can qualify. It was previously capped at 200%.

HB 109 State Park Campsite Reservations

If the great outdoors of Florida are calling you, there's good news. State residents will now get to book RV lots, cabins and campsites at Florida's state parks one month before non-residents.

HB 1275: Persons with Disabilities Registry

Lawmakers approved HB 1275 in 2023 to create safer interactions between law enforcement and those with impairments or disabilities. Officials believe poor capacity to follow instructions or conditions like Tourette syndrome could be "mistakenly perceived as an indication of hostility."

SB 144: Lactation Spaces

This new law expands state rules permitting breastfeeding in any location public or private, where mothers are authorized to be. Starting now, Florida's county courthouses will all need to have s dedicated lactation location for feeding or expression.

Our Big Bend Power Station in Apollo Beach circulates water from Tampa Bay for cooling, then sends the water flowing clean and warm back into the Bay. In the winter months the manatees leave colder waters to return to this warm and welcoming refuge.

Because of this uniquely unusual migration, we've built the **Manatee Viewing Center** so everyone could have a chance to see manatees gather. Our discharge canal is a State and Federally designated manatee sanctuary that provides critical protection from the cold for these unique, gentle animals.



Arbor Day, which literally translates to "tree" day from the Latin origin of the word arbor, is a holiday that celebrates the planting, upkeep and preservation of trees. For centuries, communities spanning the globe have found various ways to honor nature and the environment. The treeplanting tradition became prominent in schools across the nation in 1882, with schoolchildren learning about the importance of trees as well as receiving a tree to plant in their own yard. Today, Foundation Arbor Day is celebrated in all 50 states.

Why should we care about trees? Trees are our friends, they provide many benefits to our soils, our waters, our air and our wildlife. Yay for trees!

Florida Arbor Day is situated at an ideal planting time for trees in Florida. The state's warmer climate sends trees into a state of dormancy this time of year, which means transplanting is less stressful for the trees and increases the chance of survival in a new landscape.

Daylight Saving Time ~ How Did This All Get Started?

Daylight Savings Time returns soon! So why do we do it? When did it start? "Time shifting" began as a way to conserve energy. In 1748, Benjamin Franklin lightheartedly suggested the time change idea to a Paris newspaper to conserve candles. In Britain, builder, William Willett, who loved early-morning horseback rides, began fighting for it in 1905, but he died before his efforts were rewarded.

Germany was the first to introduce it, during World War I. Britain and the United Stated followed. Today, about 70 countries have some form of it. The United States government doesn't require that states mandate daylight saving, but does require that it happens at the same time on the clock and for the same stretch of the year. Arizona and Hawaii are the only states that do not partake in Daylight Saving Time. So here we go again, at 2am on March 12th, we'll "spring forward" one hour!



Before the first customer pulls up, here are tips to help make your Sale more fun and profitable!

- ▶ Cover or remove items that aren't for sale, or put up a sign saying "not for sale". Customers are annoyed to discover that an eyecatching item is off-limits.
- ► The condition and cleanliness of your items are important. No one likes to handle dirty items. Wash everything, including dishes and other breakables. Wash and iron clothing and linens, such as tablecloths, towels, napkins, curtains, etc. Polish, paint and repair your merchandise to obtain the best price. *That being said....*don't over-invest your time. It makes no sense to spend huge amounts of time and effort to paint and polish an item that will sell for 50¢.
- ▶ If an item is not in perfect working order, make sure it is labeled as such. Keep items in their original boxes with instruction manuals and warranties. (No box? Put the item and paperwork in a ziplock plastic bag.)
- ▶ Put throwaway items that might have some value to someone (parts, for example) in a box labeled "free".
- ▶ Price your merchandise. Some people won't ask the price of each item and you'll lose them. Your price may not be the right one, but at least it's a start. If several customers ask the price of an item, but don't buy or make an offer, that's a signal the price is too high.
- ▶ If you really want to move your merchandise, put up signs saying "Prices Negotiable" or "Make an Offer".
- ► Items priced the same can be grouped on one table: "\$1 table" or "50¢ box" or "All books \$1". Or tag with color-coded labels: red=\$1, yellow=50¢, etc. Post signs around the yard explaining the color code.
- ▶ Place large items under, and to the sides, of your tables where they won't block a customer's path. If the tables are barricaded behind merchandise, your buyers can't get close enough to examine the items.
- ► Customers don't mind looking through a modest-sized box of similar items (baby clothes, linens), but they won't rummage through large boxes overflowing with unsorted odds and ends.
- ► Group similar items, and don't mix things that will break or endanger customers: tools and glassware, or sharp knives with bedding. (Yes, it actually happens!)
- ► Separate heavy items and breakables, and don't arrange items so as to endanger your customers.
- ▶ Think of your sale as a small retail store. Cleanliness, lighting, display, pricing and grouping of like items are all important. Hanging many garments on hangers on a clothesline just doesn't work. They're much too heavy. That clothesline will sag to the ground in short order. Better: a clothing rack, or a shower rod across two stepladders. Or borrow a rack from a friend, church or business.
- ▶ You can encourage people to linger longer by offering coffee ② or baked goods.
- ▶ Proper lighting is important. If your sale is inside your garage, make sure customers can see the merchandise.
- ► Keep pets away from the customers. Some people don't like pets, or are afraid of, or allergic to, them. Hire a babysitter or arrange a play date for small children, who can be distracting and disruptive.
- ▶ If you're selling electrical appliances or lamps, have an extension cord and power strip on hand so buyers can confirm they're in working order. Other handy items: yardstick and tape measure, tape, extra labels and tags, string, cord, rubber bands, scissors, a knife, paper and pencil.
- ► Large appliances and furniture in excellent condition generally bring better prices if they are advertised. Let Mimi know if this applies to you. People looking for a freezer or sofa typically don't expect to find these at garage sales.
- ▶ Price items realistically. Don't expect to sell peanut butter or spaghetti sauce jars for 50¢ a piece. Don't put a \$2 tag on a bud vase you can get at Goodwill for 50¢.
- ▶ Some sellers display collectibles, antiques and fine jewelry with tags higher than shop prices. The people who will pay those high prices don't shop at garage sales; they go to antique shops and jewelry stores. Garage sale shoppers are looking for bargains.
