Dear Players and Parents,

We want to offer the incoming freshmen, new CHS students, and returning JV and Varsity players, an opportunity to get better in the off-season. We will be playing this winter again at the Pinnacle Sports Complex in Fairlawn.

The games at Pinnacle are played as 10 individual games on 10 days on MOSTLY Sundays (with a few Fridays or Saturdays). Possible dates start Nov. 4, and continue through the end of January. We will form as many teams as needed to allow everyone an opportunity to participate. The great thing about Pinnacle is that you get 75-90 minutes to warm-up and practice in three batting cages before your 80-minute game.

Winter softball is a great way to get used to the speed of the game at the high school level, and to hone your skills in a competitive environment in the offseason. OHSAA allows high school teams to play with each other from November through January as long as it is indoors. This is also a great way to allow the coaches to watch you play and assess what we need to build on as individuals/team, and improve on, in the spring.

Usually about 95 percent of the girls that play in the spring for the high school will also play in the winter. **PLEASE, if you want to play with us this winter, sign the form below and get your payment in by Sept. 23, 2016. First come, first served if we get too full. After Sept. 23rd, we may still take signups on an individual basis if the teams still have room.**

-We will have a confirmed schedule of times in late October, BUT PLEASE CLEAR OUT YOUR SUNDAYS FOR SURE! We will also have some open gyms on various weeknights to help work on things.

-The cost will be \$120 per player. Checks payable to "Cloverleaf All Sports Boosters/SB." We will keep the numbers as limited as possible to help with playing time. Schedules will be on the athletic website once we have them figured out.
