When reviewing the hospital surveillance footage, the defendant enters Parrish Medical Center's parking lot on a bicycle. The defendant parks his bicycle at the front of the hospital and walks into the emergency entrance. The defendant walks through the emergency room waiting area and throughout the hallway, which leads to the main hospital area. The defendant walks toward the elevators and is next seen on the third floor. The defendant walks past the nurse's desk and to the west wing. The defendant was seen entering room 320.

Moments later, a medical staff member is observed running towards the room. The staff member runs away from the room. Shortly after, the defendant exits the room and walks back the way he entered. The defendant appeared to walk over towards the women's bathroom, which is before the elevators. Parrish Medical Center's security staff is seen outside of the women's bathroom, where they took the defendant into custody. Within minutes, law enforcement is seen arriving and clearing the room and taking the defendant into custody.

I took a sworn statement from a witness, Karen Dufresne, who was the medical staff member seen running towards the room initially. She told me she heard a bang and ran to the room not knowing for certain what it was. She said she looked in the room and saw the defendant shoot one of the victims. She said she ran and hid until law enforcement made contact with her. When she exited, she observed the defendant lying down in custody and positively identified the defendant as the shooter in the room.

I took a sworn statement from another witness, Samantha Huppert, who said she heard a bang and walked over to find out what happened. She said the defendant walked past her as she walked to the room. She looked in the room and discovered the incident. She observed the defendant by the women's bathroom, where he was later taken into custody by Parrish Medical Center (PMC) security. She positively identified the defendant as the person she saw walking down the hallway.

I took a sworn statement of the security officers, Jason Rowley, who took the defendant into custody. He said he assisted with the handcuffing and then went to clear the room. He said he did not hear the defendant say anything.

Detective Corporal Davies took a sworn statement from a PMC security officer, Matthew Dolin, who took the defendant into custody. The security officer advised that the defendant said "I've done something wrong."

I took a sworn statement from another witness, Teresa Valle, who was the charge nurse on the floor where the incident happened. She said she observed the defendant walk into the area and then down the west wing. She said she couldn't tell if he was confused for certain so she stood up out of her chair to offer assistance. She said he then walked into the room and moments later, she heard a bang. She then heard, what she believed was one of the victims say, "There's a

...ooter." She said she heard two more shots as she ran and hid.

When law enforcement took the defendant into custody, his clothing was covered in blood and bodily matter. His clothing was taken and submitted as evidence. The video surveillance was copied to a disk and submitted to the ID Section.
