



### **ACFA – Helen Brothers/Beth Harris Memorial Scholarship Criteria**

- \* Applicant must be affiliated with the Alabama Consumer Finance Association as an employee of a Regular or Associate Member company, or be a child or grandchild of an employee of a Regular or Associate Member company;
- \* Priority of selection for the ACFA-HB/BHMS scholarship will be given to first enrollment college freshmen who enroll in the college of their choice. Should there not be a qualifying applicant in this category, then consideration may be given to an enrolled student who otherwise meets the qualifications for the scholarship. A previous winner may apply again if still enrolled in College.
- \* Applicants must fill-in and submit a complete and documented Application for Scholarship for ACFA – Helen Brothers/Beth Harris Memorial Scholarship to the ACFA-HB/BHMS Selection and Awards Committee during the period March 1 – June 20 of the scholarship year;
- \* Applicants for the ACFA – Helen Brothers/Beth Harris Memorial Scholarship are subject to interview by the Committee at the time and place specified by the Committee;
- \* Applicants shall attach a current certified transcript of grades to the Application for Scholarship from the prior educational institution attended. The minimum grade point average for consideration of the scholarship shall be 2.5 or higher;
- \* Applicants shall attach to the Application for Scholarship two signed letters of recommendation. These letters should address the applicant's ability for achievement, ability to overcome obstacles and achieve desired goals, indications of good citizenship by the applicant, and any other relevant comments.  
  
If the applicant has been out of school for four years, letters are acceptable from current and former employers and/or from the office of community service organizations in which the applicant has worked/served.
- \* \*Weight will be given by the ACFA – HB/BHMS Selection and Awards Committee to the applicant's community and/or church service record;
- \* ACFA – HB/BHMS scholarships awarded may be utilized by the student as they see fit for tuition, books, fees, or room and board if related to the enrollment in college.
- \* At the end of the enrollment period for which the scholarship has been awarded, the student shall notify ACFA of courses completed, grades and hours completed, and benefits received from the ACFA-HB/BHMS scholarship.
