RULES AND PROCEDURES:

1. Car Entry Fee: First Entry \$15 Pre- registration; \$20.00 at show; \$5.00 each for additional entries.
2. Swap Meet: \$10 pre-registration; \$15 at show per stall (10' by 20' - cars, car parts, accessories-no food sales)

4. Dash plaques will be awarded to the first 50 registrants.
5. Any class with fewer than three entries may be merged into a neighboring class at the judges' discretion.
6. Final classification of entries will be decided by the judges; all decisions of the judges are final.
