However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Funeral Director Services

Basic Services of Funeral Director and Staff

Our non-declinable fee for the services of funeral directors and staff includes, but is not limited to 24 hour availability for staff to respond to initial request for service; arrangement conference with family or responsible party; employee salaries, insurance and benefits; preparation and filing of necessary certificates and permits; recording vital statistics; preparation and placement of obituary notices; preparation of services; and coordination of service with cemetery, crematory, vault companies and others as required. Also included in this charge are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, equipment and inventory expenses, and government compliances.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Embalming of the deceased

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Forwarding of Remains to Funeral Home

Our charge includes: basic services of funeral director and staff; a proportionate share of overhead costs; transfer of remains; embalming; other preparation of the deceased, if relevant; and local transportation to airport or funeral home within 25 miles.

This charge does not include merchandise, use of facilities for viewing or ceremony prior to forwarding of the body, or shipping charges. This is for shipping in the continental United States only. We can arrange for transportation to or from other countries, but additional charges will apply.

Receiving of Remains from another Funeral Home

Our charge includes: basic services of funeral director and staff; a proportionate share of overhead costs; care of remains; local transportation of remains to funeral home; hearse to cemetery or crematory; and supervision of placement of remains in local cemetery.

This charge does not include merchandise, use of facilities for viewing or ceremony prior to disposition.

Immediate Burial

Prices range from \$ 1,485.00 - \$ 11,480.00

Our charge for an immediate burial (without ceremony) includes: basic services of funeral director and staff, a proportionate share of overhead costs; removal of remains; local transportation to cemetery; and supervision of placement of remains in local cemetery.

It does not include use of facilities for viewing or ceremony, embalming, merchandise, graveside service or cash advanced items.

*Immediate burial package does not include any private viewing by the family. No charge for single identification.

Direct Cremation

Prices range from \$ 1,650.00 - \$ 5,145.00

Our charge for a direct cremation includes the basic services of funeral director and staff, a proportionate share of overhead costs, sheltering of the deceased, transfer of remains to funeral home, utility vehicle, single ID of loved one, temporary urn and crematory fee.

This charge does not include use of facilities for viewing or ceremonies, urn upgrades, alternative container or cash advance items.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials such as fiberboard or composition materials (with or without an outside covering). The alternative containers we provide are fiberboard.

*All merchandise must meet crematory requirements.

*Direct cremation packages do not include any private viewing by the family. No charge for single identification

All financial arrangements for the funeral or memorial services must be settled prior to any public announcement of arrangements by the funeral home. Because of **FEDERAL TRUTH IN LENDING LAWS**, Scott Family Services is unable to provide in-house financing or monthly payment arrangements at the time of service. You may wish to contact your personal financial institution to provide financing if one of the following options does not meet your needs.

You may select one or a combination of the following options:

- Payment with Cash, Check, or Major Credit Card*.
- Payment by assignment of insurance by the current beneficiary. The Insurance Provider must confirm and cooperate with the payment of proceeds in a collateralized assignment.**
- Paid Pre-Need funeral plans
