In compliance with the trade regulations of the Federal Trade Commission (16 CFR Part 453), we are required to provide you this General Price List. The goods and services listed below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our services. If you are required to purchase any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. This list does not include prices for certain items that you may ask us to buy for you such as cemetery or crematory services, flowers, newspaper notices, airline charges, certified copies of the death record, etc. Those cash advance items will be shown on the statement describing the funeral goods and services that you selected.

BASIC OVERHEAD AND SERVICES OF FUNERAL DIRECTOR AND STAFF. \$2,845

Our charge for basic services of funeral and staff includes, but is not limited to, the following: staff to respond to the first request for service; arrangement conference with the family or responsible party; consultation with family and clergy; arrangement and direction desired; preparation and filing of necessary notices, authorizations and consents, other services; and attendance prior to, during and following the funeral including coordination with those providing portions of the funeral (e.g. cemetery crematory). Also included in this charge are administrative costs, equipment and inventory expenses. This fee is already included in our charges for direct cremation immediate burials and forwarding or receiving remains.

EMBALMING. \$995

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you have the right to choose an arrangement which does not require embalming, such as direct cremation or immediate burial. **Michigan law requires embalming when death was caused by certain infectious diseases, or with very limited exceptions when the body is not taken to its final destination (such as a cemetery or crematory) within 48 hours. Most common carriers also require embalming.**

***\$300 additional charge to embalm an autopsied body.**

OTHER PREPARATION OF THE BODY. \$395

Services provided may include when necessary but not limited to the following: remedial preparation of remains (with regards to direct cremations, such as private viewing or identification of remains), restoration, cosmetology, washing and disinfecting and/or removal of medical equipment such as a pacemaker.

USE OF FACILITIES AND STAFF FOR VIEWING PER DAY. \$1,295

Six hours of public visitation including one hour for the family, use of the Lee-Ellena Funeral Home amenities: children's room, hospitality suite, patios, smoking porch & private lounges outside the chapel.

USE OF STAFF AND FACILITIES FOR NEXT DAY MORNING SERVICE AT FUNERAL HOME OR OTHER FACILITY. \$875

Four hour maximum.

USE OF STAFF AND HEARSE FOR GRAVESIDE SERVICE ONLY. \$795

Staff supervision and direction at cemetery.

EXCLUSIVE USE OF ENTIRE FACILITY FOR ONE DAY (IN ADDITION TO THE FUNERAL SERVICE CHARGES). \$4,495

USE OF FACILITIES FOR ONE-DAY MEMORIAL SERVICE (6 HOURS) WITH NO HANDLING OF DECEDENT.	\$3,985
Includes Professional Services of Director and staff, one day of visitation/service, 6 hours maximum and printing package.	
HEARSE (FUNERAL COACH).	\$495
Transfer of remains to cemetery or crematory within 30 miles. The charge of additional mileage is \$2.00 per mile. \$595 for delayed interment, after luncheon. Does not apply to Great Lakes National Cemetery burials/interments after 1 pm. Monday through Friday.	
LIMOUSINE SERVICE.	\$495
Within a radius of 30 Miles, additional miles \$2.00 per mile. \$30/hour after 4 hours.	
TRANSFER OF REMAINS TO THE FUNERAL HOME (WITHIN RADIUS OF 30 MILES).	\$395
The charge for additional miles is \$2.00 per mile.

DIRECT CREMATION (CREMATION WITHOUT CEREMONIES).	\$2,795
Our charge for cremation without any viewing of the remains or a memorial service. Removal (within 35 miles), and shelter of the remains, local transportation to the crematory, necessary professional services of the funeral director and staff, obtaining authorizations and documents such as the death certificate, crematory fee and the alternative container. <i>This charge does not include the medical examiner's fee, death certificates, and any merchandise.</i>	
VIEWING OF UNEMBALMED REMAINS.	\$575
Fee includes other preparation of the body and viewing of remains for one hour in dressing room. Maximum 10 people.	
IMMEDIATE BURIAL.	\$3,895
Services include necessary professional services of the funeral director and staff, removal, shelter and other preparations of the remains; local transportation to the cemetery. <i>This charge does not include a casket or outer burial container or graveside service.</i>	
RECEIVING REMAINS FROM ANOTHER FUNERAL HOME.	\$3,495
Services include: transfer of remains from the airport or funeral home; professional services of the funeral director and staff; and other preparations of the body. <i>This charge does not include the use of staff and facilities for visitation or service, printing package or further transportation or merchandise.</i>	
FORWARDING REMAINS TO ANOTHER FUNERAL HOME.	\$3,795
Fee includes: professional services of funeral director and staff, transfer of remains from place of death, embalming, obtaining necessary authorizations, shipping container and transfer to the airport. The cost of transportation, other than local transfers, provided by the funeral home is \$3.00/mile. <i>This charge does not include a casket, the use of staff and facilities for visitation or services prior to forwarding the remains, the airline charge and the receiving funeral home charge.</i>	
PROFESSIONAL SERVICES FOR DISINTERMENT OR RE-INTERMENT.	\$800
Service includes application for disinterment, notarizing documents, filing documents with county, coordinating with cemeteries, obtaining and delivering permits and a Director witness the re-interment. <i>Fee does not include: cemetery/crematory charges, permit fees, possible transportation fees or possible necessary merchandise.</i>	
FUNERAL DIRECTOR WITNESS.	\$495
This includes, but is not limited to, Director witnessing the burial and Director assistance at church for Memorial Service.	

INTERNATIONAL SHIPPING SERVICES \$3,795

This charge includes the basic services of the funeral director and staff regarding the coordination and planning of shipping human remains to a foreign country. This charge will include, but not limited to; obtaining death certificates, local county and health department letter, apostolate of death certificate from the State of Michigan, embalming documentation, direct coordination with the consulate office of said country, letters to the consulate office, international phone calls, and planning flight itinerary with airlines carrier. **Does not include use of the facilities for any viewing or funeral service, embalming, other preparation of the body for shipment, international zinc-lined shipping container, transportation charges; such as, transfer fee, transportation to the airport or any overseas transportation.**

PRINTING PACKAGE \$385

Includes one register book, 100 prayer cards with photo, 100 acknowledgment cards, website obituary, and cross or crucifix.

INSURANCE ASSIGNMENT PROCESSING \$495

Assistance provided in securing the death benefit on valid life insurance policies and assigning funds to pay for services.

SHELTERING AND CARE OF DECEASED \$150/day

Fee applies to embalmed remains not taken to its final destination within 7 days from transfer of remains.

DELAYED CEMETERY SERVICE \$695

Fee applies when there is a delay in burial not occurring immediately following the service and replaces the hearse fee of \$380.

Does not apply to committal services at Great Lakes National Cemetery after 1 pm Monday through Friday.
