#### **Professional Services of the Funeral Director and Staff**

This fee is already included in our charges for Direct Cremation, Immediate Burial, and Forwarding or Receiving Remains. Staff available 24 hours a day, 365 days a year for Concierge Services for your loved one, Refrigeration for the first 8 days, Arrangement, interview, and coordination of service plans with cemetery, crematory, clergy, common carrier, and/or any other parties involved in the final disposition of your loved one and general clerical administration. This fee for our basic professional services and overhead will be added to the total cost of the funeral arrangements you select.

#### **Embalming**

**\$695.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. We will detail, in writing, the necessity for embalming should it be required for your service request.

As required by California B&P Code 1223c “Every licensed funeral director who holds an unembalmed deceased human body for a period longer than 24 hours shall cause the body to be refrigerated”. If refrigeration of unembalmed remains is necessary, an additional charge may be applied for extended holding. This \$475.00 is part of our Professional Services of funeral director fee for all bodies from the date we take the body into our care for up to 8 days, on the 9<sup>th</sup> day a rate of \$75.00/day begins.

The Rental Casket is an enclosure without ornamentation which has a temporary interior lining and is designed for the encasement of human remains for viewing and Cremation purposes. **A new and unused Insert is included in the cost of the rental (The insert will accompany the remains for final disposition.)**
