Upon notification that your family has chosen Jordan Valley Memorial Park, as their loved one's final resting place, please have the next of kin complete and sign the attached application. Upon completion of the application, please fax or email the application to the number provided on the form, after submitting the application, please call to confirm that we have received it. The application and the full payment must be turned in at least 48 hours prior to the scheduled burial time.

Forms of payments accepted are cashier checks, credit/debit cards, and cash; please make all cashier checks payable to: **JK Anderson Funeral Service Management**. Please be advised that a 6% processing fee will be added for all debit and credit card payments. All checks should be dropped off at Rosewood Memorial Funeral Home (1601 Redmon Road - Longview, Texas 75602) 48 hours prior to the scheduled burial time.

The scheduling for the pavilion is done on a "first come, first serve" basis. If there are multiple services scheduled at one time, the first confirmed scheduled service will have first access to the pavilion and a tent set up will be provided for any service scheduled after.

Outside containers: Cemetery rules & regulations require an outside container for the casket, which must be a minimum of a concrete box. All outer burial containers provided by an outside agent, other than East Texas Cemetery Services, will be set by Jordan Valley Staff at a fee of \$295.00.

ATTENTION Funeral Homes: All vaults must be purchased through East Texas Cemetery Services.

Please be advised if you purchased a pre-need space, **prior to the transition of ownership, you are still responsible for the opening/closing of grave fee, the maintenance fee, marker deposit, and outer burial containers.

Rules and Expectations

Wednesday October 1, 2025

****All families are required to be at least 30 feet away from the burial site, before the burial process begins; i.e., sealing of the vault, lowering of casket, etc. The cemetery staff will not begin the burial process until all family members are safely distanced away from the burial site. These measures are being put in force for the safety of the family and the cemetery staff. ****

- ****HEADSTONES ARE REQUIRED**** This measure is being put in force to avoid unmarked graves in the cemetery.
- For the convenience of our families we offer a full line of monuments and memorials. However, if you wish to purchase elsewhere, please remember you must have our approval of your selection to ensure it meets our regulations; any monuments purchased from an outside vendor will have an installation fee of \$295.00. We supervise installation of all memorial and markers at a nominal charge.
- Each grave must have a headstone no later than 90 days after burial. A \$350.00 marker deposit will be collected at the time of scheduling.
- Funeral flowers will be removed in 5 days or when they become unsightly.
- Fresh cut flowers must be placed in monument flower vases.
- The vase does not have to be retractable.
- When the flowers have withered, they will be removed by the cemetery maintenance staff.
- Potted plants, wreaths, artificial flowers placed in monument vases, and baskets may be placed the week prior to Valentine's Day, Easter, Mother's Day, Father's Day, Memorial Day, Veteran's Day and Thanksgiving Day. They will be removed one week following the Holiday.
- Christmas wreaths and winter grave decorations may be placed any time after December 1st and will be removed by the cemetery staff after January 5th and discarded.
- Artificial flowers that are placed in monument vases that are integral parts of the family monuments will not be removed until their appearance is unsightly. It is recommended that you attach the monument name to the flower arrangement.
- Visitors are reminded of the cemetery's obligation to maintain the lawns and that trimming of the grass is continuous throughout the grass growing season. Any decoration not in a monument vase constitutes a major mowing problem and will be removed.
- Digging or placement of glass jars, tin cans, rocks, metal rods, statues, wind chimes, etc. in the ground are not allowed.
- Jordan Valley Memorial Park is not responsible for any containers placed at any interment location. Owners may make inquiry for any unauthorized containers which may have been removed for park maintenance purposes. These containers are retained by the cemetery for two weeks following removal.

This measure is being taken to prevent the park from having any additional unmarked graves. As a convenience we offer a full line of monuments and memorials; payment plans are available. However, if you wish to purchase elsewhere, please remember you must have our approval of your selection to ensure it meets our regulations; any monuments purchased from an outside vendor will have an installation fee of \$295.00. The marker deposit will be refunded to the family upon receiving proof of the headstone order "paid in full" prior to the 90th day after burial. If no proof is provided by the 91st day after burial, the \$350.00 deposit will be used to purchase a minimum grave marker.
