## A. BASIC SERVICES OF FUNERAL DIRECTOR & STAFF

Our fee for the basic services of funeral director and staff include, but is not limited to, staff to respond to initial request for service; an arrangement conference with family and responsible parties; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and placement of obituary notice; shelter of remains and coordination with those providing other portions of the funeral, e.g., cemetery, crematory, vault companies and others as required. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, legal and accounting fees, insurance, building and utility expenses, secretarial and administrative costs. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee or a portion of fees are already included in our charge for direct cremations, immediate burials and in forwarding or receiving remains).....**\$1995**

## B. EMBALMING

Embalming is not required by law and may not be necessary; however, if you select certain funeral arrangements, such as a funeral with viewing, embalming is required. If you do not want embalming, you have the right to choose an arrangement that does not require you to pay for embalming, such as a direct cremation or immediate burial. If Embalming is required by law, our current charge is **\$1050**

## C. DIRECT/IMMEDIATE BURIAL

Direct or immediate burial with 20g steel dull (non-Sealed) casket, with; no embalming, public viewing, special care of remains, dressing of body and no formal funeral Service are as follows:

1. Immediate burial with casket provided by client **\$2995**
  2. Immediate burial with a Bethesda Memoria Cloth Covered or Minimum 20 Gauge Steel Non- Protective casket **\$3595.00**
  3. Immediate burial with casket selected by client (Plus cost of casket) **\$2995.00**
- \*The charge for immediate burial includes local removal of remains, transportation to the cemetery, necessary authorizations, and basic services of staff. This charge does not include the use of facilities and staff for any visitation or ceremony, prior to burial.*

## D. DIRECT/IMMEDIATE CREMATION

Direct or immediate cremation with no special preparation of body, no embalming or dressing body and no casket or special cremation container and no formal or informal funeral or viewing of decedent and/or cremains ceremony. Bethesda offers the following direct cremations

1. Direct cremation with an acceptable container or casket provided by the client **\$2,550.00**
2. Direct cremation with a fiberboard container provided by Bethesda **\$1450.00**
3. Direct cremation with a Bethesda casket selected by client (Plus cost of casket) **\$2395.00**

*\*The charge for a direct cremation includes local removal of remains, local transportation to crematory, necessary authorizations, and basic services of the staff. This charge does not include the crematory fee or the use of facilities and staff for any visitation or ceremony, prior to the cremation. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard boxes.*
