The warranties, expressed or implied, are warranties of the manufacturers, not of the funeral home. No other warranties are implied by New Tradition Funeral Services.

TERMS OF PAYMENT:

PAYMENT IS DUE IN FULL WHEN SERVICES ARE RENDERED. NEW TRADITION FUNERAL SERVICES ACCEPTS ALL MAJOR CREDIT CARDS, PERSONAL CHECKS, CASHIER'S CHECKS, AND CASH. WHEN PAYMENT IS MADE WITH A CARD, A PROCESSING FEE OF 4% OF THE TOTAL BILL WILL BE ADDED.

Itemized Selections

PROFESSIONAL SERVICES

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF.....\$1,000

Includes, but is not limited to, services of the funeral director and staff to respond to initial request for service, arrangement conference with responsible parties, coordination of service plans for final disposition, completing and filing the death certificate, obtaining proper authorizations and permits, and shelter of remains. It also includes a charge for overhead expenses such as insurance, governmental compliance, licensing, accounting fees, taxes, and other costs and expenses. *This fee for our basic services will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving of remains.)*

EMBALMING..... \$700

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. It is the policy of New Tradition Funeral Services to require embalming when an open casket service is requested.

OTHER PREPARATION \$300

This charge is for all necessary procedures such as washing, cosmetic care, dressing, and casketing of remains.

AUTOPSY CARE \$350

This charge is for additional preparation required for remains that have undergone an autopsy.

RESTORATION.....\$100/HOUR

This charge applies when restoration is necessary for viewing.

REFRIGERATION (PER WEEK) \$200

This charge applies for unembalmed remains.

HANDLING OF DISINTERRED REMAINS \$600

USE OF FACILITIES, STAFF, AND EQUIPMENT

This charge is for rental of a funeral home for visitation or service, in most locations. This charge may vary.

CASH ADVANCES

CEMETERY CHARGES

All area cemeteries require payment by the day of the interment. Some require lot verification and a signature before the grave will be opened. A 24-hour notice is usually required by the cemetery.

Alternative Service Selections

DIRECT CREMATION – TRADITIONAL FLAME BASED OR WATER BASED \$1,595 - \$6,495

This charge includes (without ceremony or private viewing) a proportionate share of the basic services fee, transfer of the remains to the funeral home (within 30 miles), minimum cremation container, transfer of the remains to the crematory, crematory fee, and \$50 toward the medical examiner/coroner cremation permit*. It does not include the cremation urn, sales tax, or other cash advances.

*For a cremation permit in Cook County, add \$100; for all other counties, add \$50.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard.

This charge includes (without ceremony and with flexible scheduling set by funeral director) a proportionate share of the basic services fee, transfer of the remains to the funeral home (within 30 miles), embalming, coordination with receiving funeral home, securing authorizations and permits, shipping container, and transportation to airport. It does not include staff or facilities for visitation or service, airline charges, sales tax, or other cash advances.

RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME\$1,600

This charge includes (without ceremony and with flexible scheduling set by funeral director) a proportionate share of the basic services fee, transfer of the remains from local airport, and transportation to local cemetery or crematory. It does not include any preparations, staff and facilities for visitation or service, graveside services, hearse, sales tax, or other cash advances.

IMMEDIATE BURIAL (RANGE OF PRICES) \$1,900 - \$6,600

This charge includes (without ceremony and with flexible scheduling set by funeral director) a proportionate share of the basic services fee, transfer of the remains to the funeral home (within 30 miles), other preparation, transportation to local cemetery, and use of equipment and staff for graveside service. It does not include staff and facilities for visitation or service beforehand, hearse, sales tax, or other cash advances.

IMMEDIATE BURIAL WITH CASKET SUPPLIED BY PURCHASER\$1,900

(OR OTHER SELECTED CASKET)

IMMEDIATE BURIAL WITH MINIMUM CLOTH COVERED CASKET.....\$2,400

Our firm offers several “green” burial options through an affiliate who is one of a select group of funeral providers approved by the Green Burial Council, a non-profit organization that encourages the use of burial as means of facilitating the restoration, acquisition, and stewardship of natural areas. For such arrangements, formaldehyde-based embalming is prohibited, as is the use of metal or concrete grave liners, burial vaults, or other permanent burial containers. Caskets, coffins, or alternative containers used to enclose and transport the dead are made of biodegradable materials and are available in a range of prices. Home wakes, public visitations, and church and graveside funerals are options that may be arranged within a time frame that green burial allows. As with all our service and merchandise offerings, detailed price information for each component is itemized in this price list above.

This charge includes a proportionate share of the basic services fee, transfer of the remains to the funeral home (within 30 miles), and transfer of the remains to Anatomical Gift Association of Illinois in Chicago.
