ITEMIZED PROFESSIONAL SERVICES

- A. Basic Services of Funeral Director and Staff** \$ 1995.00
Our charge includes consultation with the family or responsible Party; staff and facilities to respond to initial requests for Services. Coordinating service plans with cemetery, crematory, church and/or other parties involved in final disposition of the decedent, securing official documents and necessary registrations and sheltering of the decedent. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremation, immediate burial, and forwarding or receiving remains.
- B. Transfer of the Decedent to the Funeral Home** (Within 35 mile radius) One Man \$ 495.00
- C. Transfer of the Decedent to the Funeral Home** (Additional Person) \$ 150.00
- D. After hr. Removals after 5 pm-8am next day including weekends** \$ 495.00
- E. Professional Embalming** \$ 700.00
Except in certain special cases, embalming is not required by law. Embalming may be necessary however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. Embalming is the disinfection and temporary chemical preservation on the remains by a professional licensee of the State of California
