All our arrangements require either refrigeration or embalming. According to the Texas Department of Health: "No human body may be held in any place or be in transit for more than 24 hours after death and pending final disposition unless either maintained at a temperature within the range of 34 - 40° Fahrenheit, or is embalmed by a licensed embalmer in a manner approved by the Texas Funeral Commission, or by an embalmer licensed to practice in the State where the death occurred, or is encased in a container which insures against seepage of fluid and escape of offensive odors."
