We will charge you for our services in buying certain items.

Alternative Selections

Direct Cremation available from \$1,890 to \$2,090

Our charge for this service includes transfer of remains to the funeral home, services of funeral director and staff, necessary authorizations, transfer of remains to the crematory, return of the cremated remains to the funeral home. This charge does not include viewing or ceremony.

If you want to arrange a direct cremation, you can use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials. The direct cremation prices do not include the crematory charge.

Direct cremation with cardboard alternative container \$2,090

Direct Burial available from \$2,850 to \$3,050

Our charge for this service includes transfer of remains to the funeral home, services of funeral director and staff, necessary authorizations, dressing & casketing and transfer to the cemetery. This charge does not include viewing or ceremony. *The direct burial charge does not include cemetery charges.*

Direct burial with casket provided by purchaser \$2,850

In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement that does not require you to pay for embalming, such as direct cremation or immediate burial. If you select certain funeral arrangements, such as viewing or an open casket funeral, embalming may be required by the funeral firm.
