BASIC SERVICES OF FUNERAL DIRECTOR, STAFF & OVERHEAD \$2,100.00

This fee for our basic services and overhead will be added to the total cost of funeral arrangements you select. This fee is included in our charges for direct cremations, immediate burials and forwarding and receiving remains. This fee includes the following: personnel available 24 hours a day, 7 days a week to respond to initial call for service, arrangement conference, coordination of clergy, cemetery, crematory and /or other parties involved with the final disposition of the deceased, preparation of required legal paperwork, overhead including facility maintenance, equipment and inventory costs, liability insurance and governmental compliance costs.

TRANSPORTATION

All transportation in excess of 30 miles will incur a \$5.10/mile fee.

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a closed-casket service, direct cremation, or immediate burial.

FORWARDING REMAINS TO ANOTHER FUNERAL HOME (within the U.S.) \$2,995.00

This charge includes the Basic Services of Funeral Director and Staff, transfer of the deceased to the funeral home, refrigeration, and paperwork. *This charge does not include additional transportation, visitation, funeral services, weekend/holiday service, merchandise, shipping charges or other cash advance items.*

RECEIVING CASKETED REMAINS FROM ANOTHER FUNERAL HOME \$2,495.00

This charge includes the Basic Services of Funeral Director and Staff, transfer of the deceased to the funeral home from SFO or OAK airport and transportation by funeral vehicle to the cemetery or crematory within a 30-mile radius. *This charge does not include preparation of the remains, after hour transfers, visitation, funeral services, weekend/holiday service, merchandise, shipping charges or other cash advance items.*

IMMEDIATE BURIAL **\$2,895 - \$17,890**

This charge includes the basic services of the funeral director and staff, transfer of deceased to the funeral home, refrigeration, minimal preparation, and funeral vehicle to the cemetery within a 30-mile radius. Burial will be scheduled at the service provider's convenience **without service nor family present**. *This charge does not include preparation of the remains, additional transportation, visitation, funeral services, weekend/holiday service, merchandise, or other cash advance items.*

DIRECT CREMATION

\$2,545 - \$17,290

This charge includes the Basic Services of Funeral Director and Staff, transfer of deceased to the funeral home within a 30-mile radius at any time of day, 3 days refrigeration, and physical cremation. Cremation will be scheduled at the service provider’s convenience with **no service**. *This charge does not include any additional transport or staff, additional refrigeration, preparation of remains, visitation, funeral service (chapel or graveside), rush or requested cremation schedule, merchandise, cash advance items, cemetery fees, or taxes.*

If you want to arrange a Direct Cremation, you must use a combustible container. Alternative containers encase the body and can be made of materials like fiberboard or composite materials (with or without outside covering.) The containers we provide include those made of cardboard construction, wood, pressed wood, and composite materials. You may use your own container (provided it meets crematory and regulatory requirements of rigidity, opaqueness and is leak-proof), or a wood casket without metal components.
