If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body, and can be made of materials like fiberboard or composition materials with or without an outside covering. The containers we provide are cardboard. The professional service fee for cremation does include the cost of the actual cremation. It does not include the required Oklahoma Medical Examiners permit fee.

This charge includes removal of the remains, basic services of funeral director and staff, a proportionate share of overhead costs, preparation of necessary authorizations, consents, permits and registrations, embalming, and local transportation to nearest common carrier terminal. ***This does not include shipping fees, mileage outside our 50 mile radius, or use of our facilities for visitation, charges for a funeral or memorial ceremony, or shipping container or casket.***

RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME:

\$2,200.00

This charge includes basic services of a funeral director and staff, a proportionate share of overhead costs, transportation of deceased from nearest common carrier terminal, and transportation to an area cemetery. ***This charge does not include shipping charges, mileage outside our 50 mile radius, staff and facilities for visitation, a funeral or memorial service, cemetery expenses such as grave space, grave opening, or cemetery equipment, or a casket if desired if remains were not casketed prior to shipment.***

DIRECT CREMATION

\$ 1,430.00

This charge includes the basic services of the funeral director and staff, a proportionate share of overhead costs, removal of deceased from the place of death to the funeral home within a 50 mile radius of our location, refrigeration of remains, the crematory fees, and transportation to the crematory. This charge does include the Medical Examiner’s Cremation Permit Fee, but does NOT include use of our facilities for viewing or visitation, a casket or cremation viewing tray view container or sales tax on merchandise items.

NOTE: **At this time, the State of Oklahoma charges a \$200.00 fee to issue a Cremation Permit and it is included in this price.**

IMMEDIATE BURIAL

\$2,290.00

This charge includes the complete services of the funeral director and staff, a proportionate share of overhead costs, removal of the deceased from the place of death to the funeral home, and transfer of the decedent to an area cemetery. This charge does NOT include embalming, any cemetery expenses such as grave spaces, opening and closing of the grave fees, cemetery equipment, outer burial container, casket, or applicable sales tax on merchandise items. Additionally, there is no local funeral or ceremony. Immediate burial may be arranged by use of a container made of wood, or heavy cardboard, plyboard, composition materials with or without outside covering, or a casket from our regular casket selections, plus applicable sales tax.

Since McElyea & Owens LLC is a small privately owned business providing funeral service-related services and merchandise, we are totally dependent upon our client families for prompt payment of the charges for the services and merchandise we provide. We feel the payment policy listed below is in the best interests of the families we are privileged to serve.

CASH ADVANCE ITEMS: Cash advance items are the charges incurred beyond the services of McElyea & Owens Funeral Group. We extend this service as a convenience to our client families.

Therefore, payment for such advances is required to be paid at the time of the arrangement conference.

PAYMENT OPTIONS FOR TOTAL FUNERAL EXPENSES: We gladly accept the following forms of payment:

Cash, personal or certified check, Discover card, VISA card, or Mastercard.

Insurance assignment of a valid, verifiable and assignable Insurance Policy.

Amounts payable by insurance assignment will be assessed a 3% filing/convenience fee.

Through Pre-arrangement planning prior to death.

Unless using a valid insurance assignment or contracted pre-arranged planning, payment for funeral expenses is always required one day prior to the day of service.

A SIGNED CONTRACT IS REQUIRED: It is the policy of this establishment not to extend services or to provide merchandise of any nature (except for the removal of the decedent from the place of death) unless a family member, or other responsible party having the right to do so, signs a contract authorizing our firm to act per his or her requests. This is a Federal Trade Commission requirement.
