Our service includes removal of the deceased, their temporary sheltering, local transportation to the cemetery, the necessary authorizations and required services of staff. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial. Additional costs will be incurred for deceased held beyond 24 hours.

DIRECT CREMATION.....\$1,395 - \$1,795

The charge for a direct cremation includes removal of the individual, temporary sheltering of individual, necessary paperwork, plus the cremation charge (up to 250 pounds) of \$450.00, the Medical Examiner's Authorization of \$50.00, and the crematory required transfer pouch/case, and standard plastic urn.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is either a reinforced corrugated container or a leak proof, reinforced heavy duty fabric transfer pouch, as required by the crematory.

PROFESSIONAL SERVICES

Basic Services of The Funeral Director And Staff.....\$ 1,550.00

Our basic services charge includes, but is not limited to, staff to respond to initial request for services; arrangement conference with family or responsible party; preparation and filling necessary certificates and permits; sheltering of deceased, placement of obituary notices; planning of funeral arrangements; and coordination with cemetery, crematory, vault company, and others as required. Also included in this fee are overhead expenses relative to our facility such as insurance, maintenance and utility expenses, secretarial and administrative costs, and equipment and inventory expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding and receiving of deceased.)

Embalming.....\$ 925.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement, such as direct cremation or immediate burial, that does not require you to pay for it.

Pennsylvania Rules and Regulations Number 13.211 (A) requires that any human remains held 24 hours beyond death, shall be embalmed or placed in a hermetically sealed container that will not allow fumes or odors to escape or shall be kept under refrigeration; provided, however, that this does not conflict with any religious beliefs or medical examination.
