If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

This price list is offered to comply with the Federal Trade Commission's Trade Regulation Rule; Funeral Industry Practices 16 CFR Part 453. Our fees are established in consultation with a professional advisory firm, exclusively serving funeral homes.

**Service Guarantee**

If you are not completely satisfied with any of our professional services or facilities of which we cannot timely and satisfactorily correct, you will not be charged for that item of service. We take the risk out of selecting a funeral home with our written service guarantee.

**Pre-Need Price Guarantee Option**

Exclusive of CASH ADVANCES, Peter Rossi & Son Memorial Chapel and Sinchak & Sons Funeral Home guarantee only Funeral Services and Merchandise purchased in advance through a **guaranteed** contract through the Ohio Funeral Directors Association Master Trust.

**Hospice Care Pre-Need Policy**

Effective June 2017, without any financial commitment or payment whatsoever by the consumer, it is our company policy that for individuals under hospice care, we offer a price guaranteed quote honored for six months from the date on the Statement of Goods & Services Selected. The price guarantee is exclusive of CASH ADVANCES.

**Merchandise Warranties**

The only warranty on any merchandise sold by us is the express written warranty, if any, provided by the manufacturer of such merchandise. We make no warranty, expressed or implied, with respect to merchandise. A manufacturer's warranty, if any, will be provided to you.

**Payment Policy**

To lose someone you love is a devastating human experience. It can be traumatic and seriously impact one's judgment. Therefore, it is important to be realistic with respect to funeral expenditures. We do not want your choices to be more than is affordable nor less than you would like to arrange. What is important is that arrangements be in keeping with your wishes and budget. We believe in the recognition and meaningful celebration of a life that has been lived and will assist in arranging an appropriate service to meet your individual needs. We have established a uniform payment policy to serve all families fairly and to prevent misunderstandings.

***Our policy requires that financial arrangements must be completed prior to the scheduling of services or viewing times. Services can be delayed until financial arrangements are complete.***

**12 Payment Options**

Provisions for payment are due at time of arrangements. For your convenience, we accept 12 methods of payment:

- Cash ~ Check ~ Funded Pre-Arrangement Plan ~ Transferred Pre-Need from Alternate Funeral Home ~ Advanced Payment by a Forwarding / Receiving Funeral Home - Debit Card - Visa ~ Mastercard ~ Discover ~ American Express - fee of approximately 3.5% of the charged amount is added to the amount you wish to charge by the credit card processor.
- Insurance Assignment of a Verifiable Policy - fee of up to 3.50% of the assigned amount
- Financing obtained by purchaser through a bank or by LendingUSA™ ~ to check the rates you qualify for, LendingUSA does a soft credit pull that will not impact your credit score. If you choose to continue your application, your full credit report will be requested from one or more consumer reporting agencies, which is considered a hard credit pull.

**"Estate Funds" are not accepted as payment.**

**Cash Advances**

Some services and merchandise provided as cash advance items will be billed at the same amount paid by the funeral firm. This includes cemetery charge, cemetery equipment supplied by vault company, death certificates, clergy, church and musician honorarium, and public transportation.

**Basic Services of Funeral Director & Staff & Overhead:** .....\$1,500.00  
 Includes: Twenty-four hour, 365 days per year accessibility; administrative expenses; arrangement conference; planning, supervising, and coordinating service details with those involved in the funeral service; securing, preparing, and filing necessary permits, certificates, authorizations, and consents; clerical and record keeping. **Embalming:**..... \$750.00  
 Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with a viewing. It is funeral home policy that a decedent must be embalmed if a public viewing is selected. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial. When no embalming is requested or required, refrigeration is required by the funeral home.

Complimentary to all our families, we will post your loved one's obituary to our website, which allows the public to view the obituary, confirm times and locations, leave personalized messages and photos for the family and send flowers for services.

This service also allows families to post the link to their loved one's obituary to social media sites such as **Facebook, Twitter and Instagram**.

From our website, **My Valley Tributes** will air the notice of your loved one's passing on one of the local television stations.

### WiFi

Our Funeral Home has private WiFi to help you stay connected during your time in our building. WiFi is often best used to help FaceTime with out-of-town family members during visiting hours or take helpful phone calls and texts during arrangements.

*Note: All playable content for services should be previously downloaded to a device and should not rely on the WiFi connections for playability.*

### Audio Technology

Our Funeral Home is equipped with Audio Technology which enhance funeral services:

- **Bluetooth sound system** – Compatible with all Bluetooth and Auxillary Devices
  - Families may control their own music during calling hours and services via their own device or playlists may be given to the Director to be played on loop.

**Option A - DIRECT CREMATION** .....\$1,975.00

Includes:

- Removal of remains to funeral home (within a 25 miles radius, sheltering of remains, automotive equipment (removal car), cremation container (cardboard or fiberboard), transfer to crematory, cremation charges (Based on 299 lbs or less) and handling fees.
- Private family identification/viewing (small group for no more than 30 minutes, NOT PUBLIC)
- Coordination, direction, and disposition of the remains by cremation.
- Counsel/Arrangements by a Licensed Funeral Director for all procedures on a 24 hour basis.
- Filing/Obtaining of necessary permits/Certified Death Certificates (price per copy is not included).
- Preparation and presentation of the obituary to designated local and out of town newspapers and other media (price per paper is not included) and laminated obituaries (8).
- Filing of Social Security and Military applications.

## AFTER CARE

### DEATH CERTIFICATES

It usually takes about 1 to 2 weeks (6-8 weeks when the Medical Examiner / Coroner is involved) to receive the certified copies of the death certificate. When the certificate is signed by the doctor, it is filed with the Board of Health who issues the certified copies. You will be called when we receive the copies. These official certified copies will probably be needed for most legal transactions.

The "Big 5" areas which require Certified Death Certificates are:

1. Life Insurance
  - One Death Certificate is generally required *per Insurance Company, not per policy*.
  - Contact the insurance company and they will follow up with the necessary claim forms.
  - If deceased was named as beneficiary on another's policy, consider naming a new beneficiary.
2. Pensions/401Ks
  - Based on the latest receipt, contact the company of origin and follow their directives.
  - Some pensions and 401Ks will have beneficiaries named by the deceased.
  - Some pensions pro-rate payment.
3. Property (Homes & Vehicles)
  - Determine if property is Transfer on Death or held jointly.
  - If so, property will transfer by taking a death certificate, title, and marriage license/will to the Title Office.
  - If not, legal council should be considered to enter into probate.
4. Bank Accounts (including trusts, stocks, annuities and financial tools)
5. Last Will and Testament

***Additional certified copies of the death certificate may be ordered (at cost) at any time by calling the funeral home.***

### SOCIAL SECURITY

Social Security will be notified of your loved one's passing as soon as we enter the death certificate information electronically.

As described on the Social Security Administration website, the following people are eligible for survivors benefits:

- Widow or widower age 60 or older (age 50 or older if disabled)
- A surviving divorced spouse, under certain circumstances.
- A widow or widower at any age who is caring for the deceased's child who is under age 16 or disabled and receiving child's benefits.
- An unmarried child of the deceased who is one of the following:
  - Younger than age 18 (or up to age 19 if he or she is a full-time student in an elementary or secondary school).
  - Age 18 or older with a disability that began before age 22.
- In certain cases, stepchildren, step grandchildren, or adopted children may be eligible as well as parents (age 62 or older) who were dependent on the decedent for at least half of their support.
- Eligible family members may be able to receive survivors benefits for the month the beneficiary died.
- 

***If you are already receiving benefits as a spouse, your benefit will automatically convert to survivors benefits after the Social Security Administration received report of death.***

Special Lump-Sum Death Payment

- Depending on if the surviving spouse or child meets certain requirements, they may receive a special lump-sum death payment of \$255.
- For more information about this lump-sum payment, contact your local Social Security office or call 1-800-772-1213 (TTY 1-800-325-0778).
- If the deceased has a surviving spouse and is eligible for benefits, there will be a lump-sum death benefit of \$255 payable to that surviving spouse. This person must make the application for the money personally. This benefit can be applied for by telephoning the Social Security office at 1-800-772-1213.

### VETERAN'S BENEFITS

We need an original copy of the discharge papers so that an American flag can be obtained. A government grave marker is available for any honorably discharged veteran if so desired. Veterans who are receiving monthly checks for disability or pension or who are in a veteran's hospital at the time of death are eligible for a lump-sum interment allowance. Veterans in the veteran's hospital are also eligible for the transportation charge from the VA hospital to the funeral home. We can provide you with the proper forms.

### HEADSTONES

Peter Rossi & Son Memorial Chapel and Sinchak & Sons Funeral Home are happy to give recommendations on Local or regional headstone vendors. Designing and Purchase of Headstones may be done directly with selected vendors. Date of Death plaques or engravings may be arranged through the funeral home and will be treated as **Cash Advanced Items**.

### THINK AHEAD

Having experienced this loss, think ahead and consider how you may organize your estate through Pre-Planning your funeral arrangements, naming beneficiaries and specifying to whom you want to leave your belongings in a Will or Deed.
