CREMATORIUM BY-LAWS

Only human remains will be received for cremation.

Prior to any cremation taking place, an application for cremation must be properly completed, together with such further documents as may be required from time to time under the Funeral, Burial and Cremation Services Act (2002) or amendments thereto, and shall be submitted to the crematorium attendant and requisite fees shall be paid.

A body delivered to the crematorium for cremation must be delivered in a closed casket or other sturdy container and will be cremated in such casket or container. Such casket or container must be of wood or other readily combustible material. Without limiting its right to refuse to cremate in any case without assigning reasons as provided by the Funeral, Burial and Cremation Services Act (2002), Opus Tribute Group may refuse to cremate where a body is enclosed in a casket or container made in whole or in part of asbestos, bronze, fiberglass, plastic, steel or any other substance which in the Company's opinion may impair or cause damage to the cremation retort or cause difficulty in the cremation process.

Under no circumstances will an employee of Opus Tribute Group open a casket delivered for cremation. If the casket must be opened for any reason, the Funeral Director employed by the family of the deceased or his/her representative must open the casket. Crematorium officials may request signed authorizations from the family of the deceased before permitting the casket to be opened once it is delivered to the crematorium.

Opus Tribute Group will not be responsible for any jewelry or other material left in a casket or container, which is delivered for cremation.

Unless provided with another suitable container, the cremated remains will be placed in a temporary container, which may be left at the crematorium for a period of one (1) year after cremation. If, at the expiry of such period, instructions satisfactory to Opus Tribute Group for the disposal of the cremated remains have not been given, the same may be buried in the cemetery in which the cremation took place.

If any cremated remains have been buried after the one (1) year period and are to be claimed, the cost of interring and disinterring the cremated remains shall be paid before they are released.

Any urn that is to contain the cremated remains must be large enough to contain all the cremated remains. An urn that is not large enough may be refused by Opus Tribute Group and the cremated remains will be placed in a temporary container.

Any metal residue, non-combustible casket or container interior or exterior materials and identifiable body prosthesis, bridgework or similar items will be separated and recycled or disposed of by Opus Tribute Group.

Opus Tribute Group is not liable for any delay in cremation beyond its control. In such circumstances Opus Tribute Group reserves the right to secure the casket or container in a receiving area until cremation can occur.

PAYMENT OPTIONS

We are proud to offer various payment, funding and financing options to our clients. Balance is due within 30 days of signing the contract. Payment may be made by cash, cheque, debit, and most major credit cards. Beyond the allotted time, interest can be charged at a rate of 1.5% per month, which is equivalent to 18% per annum (APR). All indebtedness related to the purchase of interment rights is due at the time of interment, entombment or inurnment.

PRE-PAYMENT IN ADVANCE OF NEED

For services and supplies that are being arranged pre-need, you may pay for the services and supplies at today's price and we will place your money in a trust account/fund, where it will accrue interest until the prepaid contract is fulfilled (when the services and supplies are delivered). Pre-payment can be made by cash, cheque or credit. Funds are held in the purchaser's name.

GUARANTEE

When paid in full in accordance with the payment terms set out in the prepaid contract, the prepaid contract is guaranteed. The total payment(s) made plus interest / growth earned will be applied to the future price of the services and supplies. If the total payment(s) plus interest / growth earned are insufficient to cover the total future price of the prepaid services and supplies, we will absorb the difference as a loss. Any funds in excess of the total future price of the prepaid services and supplies will be returned or applied toward additional services, supplies and disbursements purchased at the time of need, as applicable. Conditions apply. Any changes to the prepaid contract may result in the prepaid contract being null and void and a new contract being executed with current pricing at the time changes are made.
