These prices are effective as of September 1, 2025 are subject to change without notice. The goods and services shown below are those we can provide to our customers. You may choose only those items you desire. (However, any funeral arrangements you select will include a charge for our services.) If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. This list does not include prices for certain items that you may ask us to buy for you, such as cemetery services, flowers, and newspaper notices. The prices for those items will be shown on your bill or the statement describing the funeral goods and services you selected. (We charge you for our services in buying these items.) This list does not include all the costs for final disposition that you may be required to pay.

SERVICES OF FUNERAL DIRECTOR AND STAFF

Our professional service charge includes but is not limited to counseling, availability on a 24-hour basis, staff assistance in local removal from place of death, consultation with family, cemetery, and clergy, assistance of staff in all necessary phases of arrangements and direction of visitation /funeral services, obtaining, preparation and filing of necessary notices, authorizations and consents, certificates and permits; care and arrangement of flowers, coordinating with those providing other portions of the funeral, (cemetery, crematory, and leading of procession to/from place of service) and supervising of all arrangements pertaining to the funeral service and directing of funeral and assistance to family following funeral and final disposition, and presence at place of final disposition.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burial and forwarding and receiving remains.)

EMBALMING

Except in special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement, such as a direct cremation or immediate burial, that does not require you to pay for it.

FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME / MORTUARY

This charge includes removal of remains, services of staff, embalming, receptacle for body, necessary authorizations, local transportation to airport or railhead. It does not include the services of staff or use of facilities for ceremonies prior to forwarding of remains.....\$ 3,500.00

The cost of other than local transportation in vehicles of funeral home is \$ 3.00 per mile.

RECEIVING OF REMAINS FROM ANOTHER FUNERAL HOME / MORTUARY

This charge includes temporary shelter of the remains, transportation of the remains to cemetery or crematory and required services of the staff. It does not include the services of the staff or the use of facilities for viewing or for funeral rites / ceremonies..... \$ 1,825.00

IMMEDIATE BURIAL\$ 3,800.00

Our charge for immediate burial (without any attendant rites or ceremonies) includes

- removal and shelter of the remains
- local transportation to the cemetery
- necessary services of staff and authorizations

***PLEASE NOTE: All decedents over 325 pounds will be priced at crematory discretion

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composite materials (with or without an outside covering), or pouches of canvas.❷

(Pennsylvania Rules and Regulations number 13.201 6(i) requires that any human remains held 24 hours beyond death shall be embalmed or sealed in a container that will not allow fumes or odors to escape or kept under refrigeration, if this does not conflict with a religious belief or medical examination.)

❶ The charge for a cremation authorization is levied individually by each respective county coroners office, and is subject to change without prior warning. In most cases of cremation, the coroners office in the county of death requires the funeral home to notify them of the choice of cremation for final disposition of the deceased.

❷ The Neely Funeral Home uses a corrugated cremation container at all times at no additional charge.
