## **Payment Policy**

To lose someone you love is a devastating experience. Therefore, it is important to be realistic with respect to funeral expenditures. We do not want your choices to be more than is affordable, nor less than you would like. It is important that the arrangements be in keeping with your wishes and budget. We are a family operated business and we treat every family we serve as fairly and equally as we can. In an effort to provide the finest services possible, we request that 25% of our services and merchandise and the total of all cash advance items be paid at the conclusion of the arrangement conference. If the full payment of the funeral expense balance is not received within a 30 day timeline, a late payment fee of 1% (12% per annum) will be added to the unpaid balance. In order to be fair to each family we are called upon to serve, there are no exceptions to this policy.

## **Professional Services**

## \*Basic Services of Funeral

#### **Director and Staff** \$3,450

Our fee for the basic services of funeral director and staff includes, but is not limited to, 24 hour availability of staff to respond to initial request for service; sheltering of deceased, arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation of obituary notices for newspapers and social media; coordination with those providing other portions of the funeral, such as cemetery, crematory, vault companies, and others requiring notification. Also included in this charge are overhead expenses relative to our facilities, such as professional licensing, music licensing, legal and accounting fees, insurance, building and utility expenses, parking lots and grounds maintenance, taxes, equipment, furnishings, inventory costs, record keeping, secretarial and administrative expenses. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select.

#### \$ 895 \*Embalming

Except in certain special cases, embalming is not required by law. Embalming may be necessary if you select certain funeral arrangements such as a funeral with a viewing. If you do not want embalming, you have the right to choose a funeral arrangement that does not require this service such as direct cremation or immediate burial or closed casket service.

#### **Forwarding of Remains to Another**

Funeral Home \$5,550

This charge includes and is limited to initial transfer of the deceased to the funeral home from the place of death, basic services of funeral director and staff, coordination of shipping arrangements, necessary authorizations, embalming, local transfer of deceased to airport. This charge <u>does not</u> include any shipping charges, outer shipping container, or any other use of the funeral home such as visitation, viewing, or ceremony and any other merchandise. Any deviation from this package will dictate the use of itemization of our charges from our General Price List.

#### **Receiving of Remains from Another**

This charge <u>does not</u> include casket, outer burial container, shipping charges or any other merchandise or services such as visitation, funeral ceremony, graveside or committal services. This charge includes and is LIMITED to basic services of director and staff, transfer of deceased to funeral home, alternative care (State Statute HHS 136.04), refrigeration for 48 hours, crematory charge and minimum alternative container. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are fiberboard.
