### FULL FUNERAL SERVICE FEE.....\$3,990.00

Includes: Services of Funeral Director and Staff,

### LIMITED FUNERAL SERVICE FEE.....\$2,840.00

Includes: (Graveside Services Without Embalming or Visitation)

Other Preparation of the Body, Dressing,  
Funeral Ceremony at Graveside,  
Local Transfer of Remains to Funeral Home (25-mile radius),

In compliance with the trade regulations of the Federal Trade Commission (16 CFR Part 453), we are required to provide you this General Price List. The goods and services shown below are those we can provide to our customers. You may choose only those items you desire. However, any funeral arrangement you select will include a charge for our services. If legal or other requirements mean you must buy any items that you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

### SERVICES OF FUNERAL DIRECTOR AND STAFF.....\$1,815.00

Arrangement Services: At need or Pre-need. Our charges include but are not limited to the following: consultation with family, compiling information for services and directions desired .....\$815.00

General Services: Obtaining signed death certificate and necessary permits; basic availability of staff; filing of government benefit forms; preparation and placement of local newspaper notices; preparation of register book; preparation and payment of fees for services of others; burial or cremation arrangements; and other services and assistance prior to, during and following the funeral .....\$1000.00

This fee for our services will be added to the total cost of the funeral arrangement you select. This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.

### EMBALMING.....\$875.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as direct cremation or immediate burial.

### OTHER PREPARATION OF THE BODY.....\$200.00

Washing and disinfection when no embalming, dressing and casketing of remains.

Dressing, Casketing, and normal Cosmetology.....\$150.00

Special care of autopsied cases .....\$ 85.00 per hour

Special restoration, cosmetology .....\$ 85.00 per hour

One day or portion thereof, including use of chapels; receiving and arranging flowers; flower stands, casket bier, register stand and staff.

- **Example .....**Caskets..... **\$1,195.00 (cloth-covered wood) to \$10,000.00**
- **However, caskets, such as bronze with gold plated hardware can run as high as 30,000.00**

ALTERNATIVE CONTAINERS FOR DIRECT CREMATION: (Heavy cardboard) ..... **\$100.00**

OUTER BURIAL CONTAINERS: (A complete list will be provided at our funeral home) .... **from \$1,285.00 to \$8,500.00**

- **Example .....**Outer Burial Container.... **\$1,285.00 (concrete grave liner) to \$8,500.00 (bronze lined vault)**

In most areas of the country, no State or local law makes you buy a container to surround the casket in the grave.

However, many cemeteries ask that you have such a container so that the grave will not sink in. Either a burial vault or a grave liner will satisfy these requirements.

CREMATION RENTAL CASKET: ..... **\$ 900.00**

CREMATION URNS: ..... **from \$45.00 to \$3,500.00**

- **Example ----- Urns .....\$45.00 (memento urn) to \$3,500.00 (bronze or copper urn)**

**FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME ..... \$2,115.00**

This charge includes the local removal of remains, services of staff, embalming, other preparation, necessary authorizations, and local transportation to airport or railroad. It does not include the use of facilities for viewing or any funeral rites/ceremonies prior to the forwarding of the body or shipping charges.

Professional fees for shipment by common carrier from U.S. or Canada when casket selected here (include funeral director's fee and his local transportation when the arrangements are made by us) ..... **\$795.00**

Arranging shipment outside of the U.S. (plus all costs) ..... **\$970.00**  
The cost of other than local transportation in vehicles of the funeral home is \$2.25 per mile.

**RECEIVING REMAINS FROM ANOTHER FUNERAL HOME .....\$1,815.00**

This charge includes local transportation, temporary shelter of remains, local transportation of remains by service car to cemetery or crematory and/or required staff services. It does not include other services of staff, the use of facilities for viewing or any funeral rites/ceremonies.

**IMMEDIATE BURIAL ..... \$2,305.00**

This charge includes basic services of funeral director and staff, removal of remains (25-mile radius), dressing of remains, crematory charges, securing proper permits and authorizations and transportation to a local cemetery. Exclusions include casket, vault, ceremony, visitation, embalming, cemetery charges, sales tax and other cash advances.

**LIMITED DIRECT CREMATION .....\$1,495.00\***

Our charge for limited direct cremation includes local removal, care of remains, transportation to crematory, crematory charges, cremation container, basic services of staff, securing necessary permits and authorization. Exclusions include assisting families with obituaries, sales tax and other cash advanced items. **This service is required to be paid in full prior to cremation. (Cash, Check, Credit Card with 3% fee added)**

\*Please note that the limited direct cremation fee represents a discount on our full-service charge and does not include above exclusions.

**DIRECT CREMATION .....\$2,145.00**

Our charge for direct cremation includes services of funeral director and staff, transfer of remains to funeral home (25-mile radius), cremation container, crematory charges and securing necessary permits and authorizations. Exclusions include: Any cash advanced items, sales tax.

- 1. Direct cremation with memorial service at church ..... **\$2,445.00**
- 2. Direct cremation with memorial service at funeral home ..... **\$2,445.00**

If you want to arrange a direct cremation, you can use an unfinished wood box or an alternative container. Alternative containers can be made of materials like heavy cardboard or composition materials (with or without an outside covering) or pouches of canvas. You may also use a casket.

- 1. Direct cremation with alternative container (heavy cardboard) ..... **\$1,915.00**
- 2. Direct cremation with container provided by provider (plus crematory fee) ..... **\$1,815.00**
- 3. Direct cremation in addition to the price of a cremation casket (plus crematory fee) ..... **\$1,815.00**

**CHARGE FOR CREMATION .....\$ 230.00**

**PLEASE NOTE:**

- 1. Cash Advance Items: This list includes certain items that you may ask us to buy for you, such as cemetery or crematory services, flowers, clergy, organist, church, newspaper notices, etc. The prices for these items will be shown on your bill or the statement describing the funeral goods and services you selected. We charge you for our services in buying these items.
- 2. Cemeteries or crematories may have certain restrictions concerning the type of burial or cremation container they will accept, many require the use of an outer burial container, and many have other rules, regulations, and restrictions which may limit your choices or require you to purchase certain goods or services. We have no control over the policies of cemeteries/crematories and whether your choices of funeral goods and services are compatible with your choice of cemetery or crematory.
- 3. Credit and payment policy: Half of the total charge is due on or before the day of the funeral and total balance is due within 30 days. We accept cash, check and all major credit cards, however with a credit card payment there will be a 3% fee added. Other arrangements can be made for payment such as; assignment of a verifiable insurance policy payable to the funeral home, pre-funded and pre-arranged insurance through a funeral home. In the event we extend credit for 60 days, we require two signatures from individuals who will accept financial responsibility for the final funeral expenses, parties must own local real estate or have the same stable job for over two years. We reserve the right to seek legal action on accounts 3 months past due.
