The prices for these items will be shown on your bill or the statement describing the funeral goods and services you selected.

METHOD OF PAYMENT

Payment for goods and services is expected at the time arrangements are made, unless other arrangements have been made prior to need. For your convenience we accept cash, check and credit cards including Visa, Mastercard, Discover & American Express.

There will be a 3% surcharge on cash advance items purchased with a credit card.

Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

- One-person daytime removal within 20 miles of the Sacramento office
- Refrigeration
- Basic Cremation Container - \$45.00 (*plus tax*)
- Simple Plastic Utility Urn - \$10.00 (*plus tax*)
- Cremation performed onsite at All Faith Crematory (*up to 275lbs*)
