Between Basic Immediate Cremation Services and Full Traditional Three-Day Funeral Services there are many possibilities. There is no cost or obligation to discuss your questions and options.

The following itemized fees, and packages, for our services have been calculated based on the average cost of providing these services, and reflect requests frequently made by previous clients. We are willing and able to modify our packages and service fees to meet the unique requirements of every family we serve. As well, we will be pleased to discuss choices and provide assistance if financing is required.

On the next two pages are a detailed listing of charges in Plan A, which includes two days of visitation and a ceremony on the third day. Then there are six other packages listed, Plan B through Plan G, that represent reductions from Plan A in the staff, facilities, supplies and vehicle charges. Finally Plan H details the costs for our basic cremation, or burial, service.

Please note that whether some or all of the funeral activities are held in our facilities, or locally but off-site, the costs have been determined to be equal. Where our facilities are used less, there are additional costs in staffing, vehicles, equipment and supplies to provide the services off-site. Thus, our charge is the same for both on-site and off-site services.

Since 1926, the Paul family and associates have served every family who has requested our assistance, regardless of their financial circumstances, with the highest level of professionalism, compassion, and innovation we could offer. We know that death can cause grief and we can't take that away. But we can provide some significant grief relief with our services, and that is our goal.

LICENSED, UNLICENSED AND ANCILLARY STAFF SERVICES

Basic professional fees *(requires Basic Facility Charge)*

Professional consultation with licensed personnel, which may include but is not limited to, expert advice on options to meet your needs, including essential services relating to disposition, drafting notices, planning and scheduling of services, coordinating all parties involved, advising regarding possible government benefits. Ancillary staff includes answering service, book-keeping, accounting and legal services required for the funeral services we provide.

A Basic professional fee is payable whenever we provide services to you. \$738.00

Co-ordinating rites and ceremonies Co-ordination of all rites and ceremonies, before, during and after they have been provided, including services and supplies provided by us, as well as those provided by third party suppliers, such as flowers and death notices.

Documentation – permits, forms, stationary package, etc.

Licensed Embalming of Recipient *(requires basic preparation of remains)*

Embalming is the process of replacing blood and bodily fluids with chemical preservatives. It is a process of sanitation, restoration and temporary preservation. Embalming is not legally required, but may be recommended to preserve the body between the time of death and the visitation or disposition of the deceased. Our professional funeral directors will make a recommendation based on the condition of the body and expected service needs.

* When staff, equipment, supplies and vehicles are required to provide visitation and/or ceremonies off site we have calculated that the reduction in facilities usage equals the additional cost of providing staff, vehicles, equipment and supplies off-site, consequently the charges above and below apply whether ceremonies are provided on or off site.
