If anything in this General Price List is not clear to you or you need a better understanding, please bring it to our immediate attention, so that we may clarify it for you.

Prices are effective as of February 1, 2026, but are subject to change without notice.

“The goods and services shown in this price list are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangement you select will include a charge for our basic services. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.”

PAYMENT POLICY

PAYMENT DUE DATE

- **Upfront Payment:** John T. Rhines Funeral Home, LLC requires full payment at the time of service.
- **Payment Deadline:** Full payment is required 72 hours before the service date. If full payment is not received before the specified payment deadline, John T. Rhines Home, LLC will postpone services until the balance is paid in full.

ACCEPTED PAYMENT METHODS

- **Cash:** Many funeral homes accept cash payments for services.
- **Checks:** John T. Rhines Funeral Home, LLC accepts Cashier's Checks.
 - John T. Rhines Funeral Home, LLC accepts personal checks with verification through TELECHEX.
 - A \$150.00 fee will be assessed for any check returned unpaid by the bank for any reason. Cashier's Checks are accepted.
- **Credit/Debit Cards:** John T. Rhines Funeral Home, LLC, accepts Mastercard, Visa, American Express and Discover Card.
- **Insurance:** John T. Rhines Funeral Home, LLC will accept insurance assignments with policy verification thru our third-party verification company.
 - John T. Rhines Funeral Home **does not** accept assignments on insurance policies dated for less than two years during the contestable stage.
 - A 5% insurance processing surcharge will be added to the amount assigned for any insurance assignment accepted.

PAYMENT PLANS

- **Installment Plans:** John T. Rhines Funeral Home **does not** offer installment plans for At-Need services.
- **Pre-Need Contracts:** John T. Rhines Funeral Home allows individuals paying in advance for services, locking in current rates, payment flexibility. A family wishing to make a pre-arrangement must make a down payment for one-third of the total of the contract, with monthly payments for the remainder until the contract is paid in full.
- **Down Payment:** If full payment cannot be made at the time funeral arrangements are made, a down payment will be required. Full payment of the service contract is due 72 hours before the date of the funeral service.

FINANCIAL ASSISTANCE

John T. Rhines Funeral Home, LLC may offer assistance to families facing financial hardship, such as offering lower cost services or extending payment deadlines at the discretion of the Funeral Director(s) or company owner(s).

DOCUMENTATION REQUIREMENTS

John T. Rhines Funeral Home, LLC may require the family to complete specific **documentation** to confirm payment details, beneficiary information (in the case of insurance), and a signed contract for services.

LATE PAYMENT AND NON-PAYMENT POLICIES

- **Late Fees:** If a payment is not received by the agreed-upon date, John T. Rhines Funeral home, LLC may charge late fees or interest on the unpaid balance.
- **Account Suspension:** If full payment is not received 72 hours before the service date, John T. Rhines Funeral Home, LLC will postpone services until full payment is received.
- **Collection Actions:** In the event of continued non-payment, John T. Rhines Funeral Home, LLC may turn the account over to a collections agency.

REFUND POLICY

Refunds for Overpayment: If there is any overpayment or unused funds after the funeral service is completed, John T. Rhines Funeral Home, LLC will issue a refund to the family.

Cancellation Policy: If a family cancels a pre-need contract or funeral services before the actual service occurs, John T. Rhines Funeral Home, LLC, will issue a refund for the amount paid within 14 days of the request for refund or cancellation.

PROF. SERVICES OF FUNERAL DIRECTOR, STAFF, AND OVERHEAD \$3,500.00

Non-Declinable Descriptive Listing of Services with Itemized Overhead Expenses

Our fee for the services of the funeral director and staff includes, but is not limited to, staff to respond to initial request for services: arrangement conference with family or responsible party; preparation and filing of necessary authorization and permits; recording vital statistics; general clerical administration in completing various forms associated with the service; filing and obtaining death certificates and other forms and claims; notary service; coordination with those providing other portions of the funeral , e.g. cemetery, crematory, clergy, and others. (The funeral home has incorporated into the above fee a basic facility charge, which is used to meet overhead expenses such as maintenance and utility expenses; parking lots and real estate taxes; insurance and administrative expenses and government compliance.) **The fee for our basic professional services will be added to the total cost of the funeral arrangement you select. This fee is included in our charge for direct cremation, immediate burials and forwarding and receiving remains.**

TRANSFER OF REMAINS FROM PLACE OF DEATH TO FUNERAL HOME

(Hospitals, Nursing Homes and Medical Examiner’s Office, Residence) \$595.00

This fee is applicable to removal within a 40-mile radius of the funeral home. Additional mileage will be charged at a rate of **\$2.00** per mile.

EMBALMING \$995.00

Professional preservation; specialized care and handling of the deceased, including supplies. Except in certain cases the law does not require embalming. Embalming may be necessary however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as immediate burial or direct cremation.

ALTERNATIVE FUNERAL SERVICES

DIRECT CREMATION \$3,100.00

Our charge for a Direct Cremation without any ceremonies includes removal of remains, necessary arrangements, filing of death certificate, transfer of remains to crematory and cremation. (If you want to arrange a direct cremation, you can use an alternative container). Alternative container encases the remains and can be made of fiberboard or composition material with or without outside covering.

FORWARDING REMAINS TO ANOTHER FUNERAL HOME \$2,995.00

This charge includes basic services of funeral director and staff, removal of remains from place of death, necessary services of staff, embalming filing of death certificate, air tray and transportation to airport. This charge does not include visitation or funeral ceremony prior to the forwarding of the remains.

RECEIVING REMAINS FROM ANOTHER FUNERAL HOME \$2,790.00

This charge includes transportation of remains to funeral home, temporary shelter of remains, necessary services of staff and transportation to cemetery. This charge does not include visitation or funeral ceremony and limousine service.

Service Option B includes the Basic services of the Funeral Director and Staff, Embalming, Dressing, Cosmetics, Hairstyling and Casketing of Remains, Removal from place of death, Use of facilities and staff for funeral ceremony of equipment and staff for church services, Hearse (for church service) or Transportation of Remains to Crematory and staff to pick up Cremains. Ashes from Crematory, 1 Limousine, Rental Casket, and Cremation Fee*.

Service Option B **does not** include an urn. If you choose to select an urn, John T. Rhines Funeral Home will provide you with a price list for urn selections.

*If the death takes place in the District of Columbia or Virginia, the \$100.00 Cremation Approval Fee will be added to the package price to cover the Medical Examiner's cremation approval fee required by law.
