BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF **\$1395.00**

Our charge includes: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our overhead cost. ***This fee for our basic services and overhead will be added to the total cost of the funeral arrangement you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.***

Our charge for a direct cremation (without ceremony) includes: Basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; Free newspaper death notice, transportation to and from crematory; necessary authorizations; initial container to receive the cremains and the cremation process. **This charge does not include any other services or merchandise.**

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are cardboard containers.
