GENERAL PRICE LIST/SCHEDULE OF FEES

The goods and services shown herein are those we provide to our customers. You may choose only those items you desire. However, any funeral arrangement you select will include a charge for our basic services and overhead. If legal or other requirements mean you must purchase any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

DIRECT CREMATION SERVICE FEE (This price includes the following)-----\$995.00
Basic Service fee of the Funeral Director and Staff, transfer of the remains from the place of death to the crematory (Local Antelope Valley), refrigeration as required by law, minimum cardboard cremation container, the cremation process, and a temporary urn. There will be an additional charge for transfers that require a second person. **Cash Advances (Legal copies of the Death Certificate, Disposition Permit, Dept. of Consumers Affairs fee, and Sales Tax) are not included in the Direct Cremation Service Fee.**

BASIC SERVICES OF THE FUNERAL DIRECTOR AND STAFF-----\$300.00
This is a basic fee that we charge every family for our professional expertise in assisting them with their preferences. Our charge includes, 24 hour availability of staff to respond to initial request for service; consultation and coordination with family or other responsible parties for the arrangement of desired services; preparing and filing of the death certificate and any other necessary authorizations and permits (consulate fees not included); recording of the vital statistics; consultation and coordination with related agencies such as, cemeteries, insurance companies, Postal services and any others as requested or required. Also included in this fee is: overhead expenses relative to our facilities such as, professional licensing, accounting fees, insurance, building, utility and maintenance costs, taxes, and administrative and State/Federal compliance expenses. **(All Valley Cremation Service does not offer certain services such as Traditional funerals, Immediate Burials, and Forwarding or Receiving remains).**

TRANSPORTATION-----\$495.00
Transfer of the deceased from the place of death to the Crematory within local area* is included in the direct cremation service fee.
Additional fee for transfers that require a second person (home or residence death)-----**\$95.00**

***Local area includes the Antelope Valley. Other areas will be determined by rate schedule.**

REFRIGERATION-----\$100.00

Refrigeration of decedent as required by law and up to five (5) days is included in the cremation service fee. After five (5) days, refrigeration is charged at the rate of \$50.00 per day.

ALTERNATIVE CONTAINERS-----\$75.00 to \$795.00

All Valley Cremation Service maintains a wide selection of cremation containers for your convenience. California Law requires the use of a rigid, leak resistant container for cremation.

CREMATION URNS-----From \$25.00

All Valley Cremation Service maintains a wide selection of cremation urns to choose from. Ask your arrangement counselor for a complete list of cremation urns that we offer.
