The obligation of Evergreen Crematory shall be limited to the cremation of the pet and the disposition of the cremated remains. The undersigned agrees to hold harmless and release Evergreen Crematory, it's agents and employees from any and all loss, damages, liability or cause of action in connection with the cremation and disposition of the cremated remains as authorized herein.
