However, any funeral arrangements you select will include a charge for our services. If legal or other requirements mean you must buy an item you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral service and merchandise you selected. This list may not include prices for certain items you select such as cemetery charges or crematory services and newspaper notices. The estimated or final prices for those items will be shown on the itemized statement describing the funeral services and merchandise you selected. We will charge you for our services in buying certain items.

General Price List

Alternative Selections

Direct Cremation available from \$1,595 to \$1,795.

Our charge for this service includes transfer of remains to the funeral home, services of funeral director and staff, necessary authorizations, transfer of remains to the crematory, return of the cremated remains to the funeral home. This charge does not include viewing or ceremony.

If you want to arrange a direct cremation, you can use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials. The direct cremation prices do not include the crematory charge.

Direct cremation with container provided by purchaser \$1,595.

Direct cremation with cardboard alternative container \$1,795.

Direct Burial available from \$1,695 to \$1,895.

Our charge for this service includes transfer of remains to the funeral home, services of funeral director and staff, necessary authorizations, dressing & casketing and transfer to the cemetery. This charge does not include viewing or ceremony. *The direct burial charge does not include cemetery charges.*

Direct burial with casket provided by purchaser \$1,695.

Direct burial with alternative container \$1,895.

Transfer of Remains to Funeral Home (including personnel & equipment) \$275
(Charges for vehicle outside 25 mile radius - \$2.75 per mile)

Embalming (including use of preparation room) \$325

In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement that does not require you to pay for embalming, such as direct cremation or immediate burial. If you select certain funeral arrangements, such as viewing or an open casket funeral, embalming may be required by the funeral firm.
