CATEGORY I: Professional Services

A. BASIC SERVICES OF THE FUNERAL DIRECTOR AND STAFF \$2,395.00

Our minimum services fee is for basic non-declinable services and may include, but not limited to the following:

1. Staff response to initial request for services and arrangement conference with responsible party to determine service desired.
2. Coordinating service plans with cemetery, crematory and/or other parties involved in the final disposition of the deceased.
3. Retention and care of remains prior to the commencement of post death activities.
4. Office and staff to process death certificates, state permits, and required authorization.
5. Office staff to prepare and process death notices, obituaries, transcripts, clergy records, social security, veterans applications, and required state forms.

This fee for our basic services will be added to the total cost of the funeral arrangements you selected. (This fee is already included in our charge for direct cremations, immediate burials, and forwarding or receiving remains)

C. EMBALMING

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement which does not require you to pay for it, such as a direct cremation or immediate burial. If you choose to have an embalming performed, the decedent may be embalmed at a location other than this registered Mortuary. *No Human Remains may remain unburied or uncremated in New Jersey for more than 48 hours unless embalmed or refrigerated. (N.J.A.C. 8:9-1.-)*

(N.J.A.C. 13:36-8, 10)

Our package charges for immediate burial include basic services of funeral director and staff, the local (within 20 miles) transfer of remains to the funeral home, the basic sheltering of remains, the obtaining of necessary permits and authorizations, and local transportation to the cemetery, sanitary care and preparation of the remains for identification. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to burial, or any sheltering for days on which no post death activities occur. Nor does it include the actual cost of the grave at the cemetery, or the cemetery's charges for opening and closing of the grave.

D. DIRECT CREMATIONS

Prices Range From \$2,170.00 to \$10,565.00

Our charges for direct cremation include basic services of funeral director and staff, the local (within 20 miles) transfer of remains to the funeral home, the overnight sheltering of the remains, the obtaining of necessary permits and authorization, local transportation to the crematory, sanitary care and preparation of remains for identification. This charge does not include the use of facilities and staff for any visitation or ceremony, public or private, prior to cremation, or any sheltering for days on which no post death activities occur. Nor does it include the actual cost of the cremation process, which is a crematory charge.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like corrugated cardboard, fiberboard or composition materials (with or without an outside covering). In most cases, the containers we supply are deluxe wood based cremation trays or wood lined leak resistant cremation trays.
