## GENERAL PRICING LIST

These forms are prepared and presented to you in compliance with the Laws of the Federal Trade Regulation Rule for “Funeral Industry Practices” dated April 30, 1984 and the Maryland State Board of Morticians.

These prices are effective as of **August 22, 2020**, but are subject to change without prior notice.

The goods and services shown below are those we can provide to our customers. You may choose only items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected

**Basic Services of Funeral Director, Staff, and Overhead ..... \$1,985.00**

Our fee for the services of funeral director and staff includes, but is not limited to, twenty-four hours availability, consultation with family; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; preparation and listing of obituary notices; staff assistance prior to, during and following the funeral, including coordination with those providing other portions of the funeral, e.g. cemetery, crematory and others. In addition, this fee includes a proportionate share of our basic overhead costs. This fee is for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

**Embalming ..... \$985.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

***According to §5-513(b) If the unembalmed body of the decedent is to be stored for more than 48 hours before final disposition, a funeral establishment or crematory shall maintain the body with refrigeration and at a temperature determined by regulation.***

 Our charge for receiving remains, (without ceremony) includes; basic services of funeral director and staff; a proportionate share of overhead costs; receiving remains; and local transportation to cemetery (using minivan). This charge does not include visitation, rites or ceremonies, merchandise or cash advance items.

**Immediate Burial** ..... \$1,895.00 - \$11,115.00

Our charge for an immediate burial, (without ceremony) includes; basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; and local transportation to cemetery (using minivan). This charge does not include visitation, rites or ceremonies, merchandise or cash advance items.

**Forwarding Remains to another funeral home** ..... \$1,895.00

Our charge for forwarding remains (***within the United States***), (without ceremony) includes; basic services of funeral director and staff; a proportionate share of overhead costs; receiving remains; and local transportation to airport (using minivan). This charge does not include visitation, rites or ceremonies, merchandise or cash advance items.

**Forwarding Remains to another funeral home** ..... \$5,995.00

Our charge for forwarding remains (***Outside of the United States***), (without ceremony) includes; basic services of funeral director and staff; a proportionate share of overhead costs; receiving remains; and local transportation to airport (using minivan). This charge does not include visitation, rites or ceremonies, merchandise, casket, or cash advance items.

Consulate Fees. (These fees are based upon each individual consulate) Obtaining Local Paperwork for shipment (per stop) ..... \$195.00

**Direct Cremation Service** ..... \$985.00 - \$10,415.00

Our charge for Cremation, (without ceremony) includes; basic services of funeral director and staff; a proportionate share of overhead costs. This charge does not include *visitation, rites or ceremonies, merchandise or cash advance items, or transportation beyond 20 miles.*

***According to §5-513(b) If the unembalmed body of the decedent is to be stored for more than 48 hours before final disposition, a funeral establishment or crematory shall maintain the body with refrigeration and at a temperature determined by regulation.***

***Crematory requires container.***

- A) **Direct Cremation** with container provided by customer,  
(Cremated remains will be returned in a plastic temporary container)..... \$985.00
  - B) **Direct Cremation** with fiber board container  
(Cremated remains will be returned in a plastic temporary container)..... \$995.00
  - C) **Direct Cremation** with fiberboard container purchased from Funeral Home  
(Plus cost of casket) ..... \$995.00
  - D) **Cremation** with private family viewing (***no embalming***) includes disinfection  
and limited to 15 mins ..... \$1,770.00
  - E) **Cremation** with 1 Hour Memorial Service (no viewing) ..... \$2,995.00
  - F) **Cremation** with private family viewing (1hr) includes embalming, dressing,  
casketing and cosmetology, and cremation container (NOT A CASKET) ..... \$3,295.00
  - G) **Viewing and Cremation** (limited to 2 hrs, time selected by Funeral Home)  
Includes: dressing, casketing, cosmetology, embalming. Not included: Casket ..... \$4,395.00
