IMPORTANT NOTICE ABOUT PAYMENT

It is the desire of Thompson Rose Chapel, that a family selects a funeral service that is within their means. Therefore, we do not extend credit which may create a financial hardship by overspending. Payments for services are due at the time of your arrangement conference. It is the policy of Thompson Rose Chapel to not schedule service day and time until payment has been secured. For your convenience we accept cash, checks, Visa, MasterCard, American Express and debit cards with the Visa/MasterCard symbols and verified assignable insurance policies. Use of insurance policies will require that you also pay a processing fee in the amount of 3% of the total assignment.

*The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean that you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected. This general price list does not include prices for certain items that you may need or ask for such as death certificates, permits, cemetery fees, floral arrangements and newspaper notices. The prices for these items will be shown on your statement describing the goods and services you selected.*

ITEMIZED PRICES FOR PROFESSIONAL SERVICES

Basic Services of Funeral Director and Staff \$1,595.00

Our basic services of our funeral directors and staff includes, but is not limited to the availability of our staff 24 hours a day, 365 days a year to respond to your initial call, conducting the arrangement conference, planning the funeral, consulting with family and clergy, temporary shelter of the remains, preparing and filing the necessary authorizations and permits, coordinating with cemetery, crematory or other third parties. In addition this fee includes a proportionate share of our basic overhead cost, such as facility maintenance, inventory cost, insurance and administrative expenses. This fee for our basic services and overhead cost will be added to the total of funeral arrangements you select. This fee is already included in our charges for direct cremation, immediate burial, and forwarding or receiving remains.

Embalming..... \$595.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary however, if you selected certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you pay for it, such as direct cremation or immediate burial.

TRANSPORTATION AND AUTOMOTIVE EQUIPMENT

All transportation charges are based on a 35-mile radius, beyond this radius, additional fees will be charged at \$3.00 per mile measured one-way. Additional fees apply to limousine service beyond 4 hours at the rate of \$100.00 per hour.

FORWARDING REMAINS***\$1,550.00***

This selection includes applicable professional services, basic overhead, transfer of deceased to the funeral home, embalming, temporary shelter of remains, and transfer to local airport.

This fee does not include dressing and casketing, any visitation, services, shipping containers or other items you may need or desire.

RECEIVING REMAINS***\$1,300.00***

This selection includes applicable professional services, basic overhead, transfer of deceased to the funeral home, temporary shelter of remains, and transportation to local cemetery (within 35-mile radius). **This fee does not include** any visitation, services, dressing, casketing or other items you may need or desire.

DISINTERMENT FEE (does not include a casket, cemetery charges or other desired items).....***\$1,500.00***

GRAVESIDE SERVICE\$2,195.00

This selection includes basic services of the funeral director and staff, transfer of deceased to the funeral home, embalming or refrigeration, dressing and casketing, identification viewing and transportation to local cemetery (within 35-mile radius).

IMMEDIATE BURIAL

This selection includes basic services of the funeral director and staff, transfer of deceased to the funeral home, refrigeration, identification viewing and transportation to local cemetery (within 35-mile radius).

Immediate burial with casket provided by purchaser \$1,995.00
Immediate burial with minimum cloth covered wood casket \$2,990.00

DIRECT CREMATION

Our charge for direct cremation (without ceremony) includes: basic services of funeral director and staff, transfer of deceased to the funeral home, refrigeration, identification viewing, transportation to crematory, cremation container and cremation fee.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we regularly offer for sale are fiberboard (cardboard) containers.
