**TO THOSE WE SERVE**

*Federal and State agencies have determined that itemization of funeral services is essential for the benefit of the general public, to assure that consumers are not asked to pay for services they do not receive. It is essential that each item of service in addition to our basic fee for services be identified. In all categories of service, a basic fee will be charged, plus a fee for each requested or required item of service. However, the complete and total quotation for Direct Cremation without formalities is all inclusive except for urn cost, sales tax, and any fee associated with the final disposition of the cremains. Other options are also available. It is our sincere concern that every requirement you may have be fulfilled, in addition or apart from our standard offerings as listed herein. Please feel free to express yourself to our staff. We will make every effort to meet your needs.*

The goods and services in this pamphlet are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for basic services and overhead. If legal or other requirements mean that you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

**“Prior to drafting any contract for goods or services, the responsible party or the decedent’s survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or part, by or on behalf of the decedent”**

**SERVICES OF FUNERAL DIRECTOR & STAFF \$ 2,530.00**

This is a basic fee we charge every family for our expertise in assisting you with your needs. This fee includes, but is not limited to, a proportionate share of taxes, licenses, utilities and business expenses required to serve the public, availability 24 hours a day, 365 days a year, conducting the arrangement conference, planning a funeral or memorial service, consulting with family and clergy, writing and submitting obituary ( not including charges by newspaper agency), clerical preparation of death certificate for certification by physician or coroner, insurance, union papers, pensions, necessary authorizations and permits, (does not include fees of government, state or local agencies ), coordination with cemetery, crematory or other third party. The fee for services of funeral director and staff will be added to the total cost of the funeral arrangements you select. (Limited Services).

**USE OF STAFF AND EQUIPMENT FOR GRAVESIDE SERVICE OR MEMORIAL SERVICE \$ 830.00**

This fee is charged in addition to limited services of funeral director and staff.

**EMBALMING \$ 730.00**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or direct burial.

**REFRIGERATION \$ 160.00**

If embalming is declined, refrigeration of the remains is required by law after 24 hours of death. The cost of refrigeration is \$160.00 per day, minimum of 24 hours.

**SHELTERING OF REMAINS \$ 120.00**

Sheltering of remains, embalmed or not embalmed after 4 business days. \$120.00 per day.

**OTHER PREPARATION OF THE BODY \$ 295.00**

Includes bathing, disinfecting, dressing and casketing, cosmetics, hairdressing, personal details and minor restoration.

**SPECIAL CARE OF AUTOPSIED REMAINS \$ 485.00**

**TRANSFER OF REMAINS TO FUNERAL HOME \$ 660.00**

Within Butte County. Additional mileage outside of Butte County will be charged and quoted per mile. If a second attendant is required add \$ 90.00

*The price quoted for receiving and forwarding remains are based on limited services of funeral director and staff. Transfer of remains to funeral home, obtaining signed death certificate, and embalming for forwarding.*

## DIRECT CREMATION (NO FORMALITIES)

Prices range from \$2,530.00 to \$7,675.00 including limited Services of funeral director and staff, transfer of the remains to the funeral home, cremation. **Additional charges** will be made for certified copies of the death certificate, State filing fee, Department of Consumer affairs fee, urns, sales tax, scattering or shipping the cremains, and cremation container. If you want to arrange a direct cremation you may use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without outside covering).

The containers we provide are an unfinished cardboard container, a finished cardboard container or any of our wood caskets.
