The goods and services shown in this General Price List are those we can provide our customers. You may choose on the items you desire. However, any funeral arrangements you select will include a charge for our basic service and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement describing the funeral goods and services

### ITEMIZED PROFESSIONAL SERVICES

**A. Basic Services of Funeral Director and Staff** \$1995.00

*Our charge includes consultation with the family or responsible Party; staff and facilities to respond to initial requests for Services. Coordinating service plans with cemetery, crematory, church and/or other parties involved in final disposition of the decedent; securing official documents and necessary registrations and sheltering of the decedent.*

*This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremation, immediate burial, and forwarding or receiving remains.*

**B. Transfer of the Decedent to the Funeral Home (Within 35 mile radius)** \$225.00

**C. Professional Embalming** \$600.00

*Except in certain special cases, embalming is not required by law. Embalming may be necessary however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.*

*Embalming is the disinfection and temporary chemical preservation on the remains by a professional licensee of the State of California*

**D. Other Preparation of the Body**

*If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials with or without an outside covering.*

Our package selections are designed to simplify the arrangement process and to assure the family that most desired services will be provided without additional cost and to offer a significant monetary savings compared to the itemized price list. Although services may be selected from the itemized portion of the General Price List, the following list of commonly selected package services may help you to select the appropriate arrangements.

The following packages include only the items listed in each individual package. Additional merchandise you select and the cash advance items are not included.

The nonuse of goods and services contained within any of the alternative package selections will **NOT** result in a reduction of the price of the alternative package selected.

You may elect to purchase specific goods and services on an itemized basis. Any items or services not included in the package will be offered as listed on the itemized portion of the General Price List.

Transportation for removal, services or delivery beyond the 35 miles radius is subject to additional charges. The rates are available and printed in a rate booklet at the funeral home and will be quoted at the time of need.
