BASIC SERVICES OF FUNERAL SERVICES AND STAFF

In addition, this fee includes a proportionate share of our overhead costs. **This fee for our basic services and overhead will be added to the total cost of the funeral arrangement you select. (This fee is already included in our charges for direct cremations, immediate burials and forwarding or receiving remains.)**

CREMATION SERVICE

DIRECT CREMATION

Our charge for a direct cremation includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to and from crematory; necessary authorizations; initial container to receive the cremains; and the cremation process. These charges do not include any other services or merchandise.

****Does NOT include Urn, Certified Copied of Death, Clergy, Musician, Newspaper Notice, Flowers and Programs.*

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are a cardboard container, the hardwood rental unit or the casket of the purchasers' choice.

If expressly stated by you, the account for services provided may be forwarded to a legal firm or insurance company, etc. for payment.
3. We take all reasonable precautions to ensure that your personal information is kept safe from loss, unauthorized access, modification or disclosure.
