The survivor of the deceased who is handling the funeral arrangements, or the responsible party, is entitled to receive, prior to the drafting of any contract, a copy of any agreement that has been signed and paid for, in full or in part, by or on behalf of the deceased, and that is in the possession of the funeral establishment. Basic Services of Funeral Director and Staff and Overhead **\$895.00**
Our services include: conducting the arrangement conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of basic overhead cost. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

Embalming **\$395.00**
(Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.)
